CALI – New Sign On System for CALI.org

CALI's new website, which hosts over 300 lessons in 29 legal topic areas, is now available. Faculty will find that the lessons haven't changed, but the new site will provide improved stability and support new features and services for users.

To use the new site you will need to register on the CALI site and enter the school's authorization code. The faculty authorization code for our school is **GOLDGAfac84**. During the registration process you will also create your own password. In subsequent visits to use lessons, you will only need to enter your email address and your password.

To register go to CALI's new homepage **(www2.cali.org)** and click on the 'Not a registered user yet?' link.

The CALI lessons are a valuable resource and are easily incorporated into traditional course materials. They can be assigned to reinforce topics covered in class or to introduce topics prior to discussion. The lessons provide an opportunity for students to practice applying the concepts they are learning. You also may modify the text in most of the lessons to accommodate your lectures. Completion time for most lessons ranges from 30 - 60 minutes.
