GENERAL INFORMATION

History

Golden Gate College is an affiliate of the Y.M.C.A. and is a non-profit educational institution of collegiate grade. The Law School was established in 1901 as a branch of the Y.M.C.A. and was the first law school in California to offer evening instruction. It was incorporated in 1910, with the right to confer degrees. In 1923 Golden Gate College was established and separately incorporated under its present name. The College is a member of the American Council on Education and is accredited by the Northwest Association of Secondary and Higher Schools.

The Law School is on the approved list of the American Bar Association and is accredited by the Committee of Bar Examiners of the State of California. Graduates of the school are qualified to apply for admission to practice in any state of the United States.

Location

The Law School is located at 220 Golden Gate Avenue and is readily accessible to all parts of San Francisco and the Bay Area. The San Francisco Civic Center, the Federal and State Office Buildings, state and federal courts and most governmental agencies are located within a few blocks of the school thus affording unusual opportunities for research and for the observation of law and government in action.

Purpose and Objectives

Experience and the democratic tradition indicate that the evening law school, conforming in all respects to the standards established for approved law schools, is a necessary part of our legal educational system. Such a school exists to provide qualified men and women who must work during the day, with the opportunity to obtain a legal education comparable to that furnished by the day law school, with the only significant departure being in the fact that evening instruction must, of necessity, be spread over a longer period of time than day instruction. Golden Gate College School of Law is dedicated to providing that opportunity to qualified men and women.

The faculty of the school is composed of several full-time professors, who are available for student consultation and assistance at all times, and of prac-

ticing lawyers teaching subjects for which they are particularly qualified by training and experience.

The course of study is designed to qualify the graduate for practice in any place in the United States, but proceeding on the assumption that most students intend to practice in California, full instruction is given in all significant phases of California law.

Law Library

The law school library is open for student use during the day and evening, including Saturdays, Sundays and holidays. The San Francisco City and County Law Library, located on the fourth floor of the City Hall, the branch county law library located in the Mills Building and, for students residing outside San Francisco, the law libraries of the various bay area counties are open to students in the law school. Students in the law school may also make use of the facilities of the College library.

Tuition and Fees

Tuition is \$17.50 per semester unit. The Law School Association fee is \$2.50 per semester, except summer. A graduation fee of \$20.00 is payable at the beginning of the final semester. Tuition and fees are payable each semester on enrollment; they may be paid in full at that time or they may be paid in four monthly installments. Tuition for courses extending over more than one semester is prorated, on a unit basis, between the semesters. A fee of \$5.00 is payable on application for admission and a fee of \$1.00 is payable each semester at registration.

Fees are not refundable. Tuition accounts of students who withdraw or are dropped during a semester will be adjusted and refunds made or credit given according to the schedule in the General Bulletin of the College.

Veterans

Golden Gate College is approved for training under Public Law 550. It is also approved for California Veteran benefits.

Veterans who have been discharged under conditions other than dishonorable may be eligible for educational benefits. It is recommended that the veteran inquire at the local office of the Veterans Administration or consult the Veterans' Counselor at Golden Gate College regarding specific details of his eligibility.

Veterans must enroll before the end of the second week of the semester to obtain full tuition from the Veterans Administration.

California veterans who are no longer eligible for training under Federal laws may still apply for educational benefits under California Veterans Educational Institute Act.

Auditing of Courses

Members of the Bar of the State of California or of another state, and graduates of approved law schools are permitted to audit courses. The fee for auditing is \$17.50 per semester unit.

Books and Supplies

Students must obtain all required case books and texts. In addition, each student must, upon commencing law study, obtain a law dictionary and a set of the basic California Codes. Students who intend to do most of their preparation at home will find it necessary to purchase certain additional texts and other materials to supplement their study. All books can be purchased through the College Bookstore at list prices.

Golden Gate Law School Association

Professional and social activities in the law school are arranged by the officers of a student organization, the Golden Gate Law School Association.

ADMISSION REQUIREMENTS AND PROCEDURES

Admission Requirements

1. Requirements for admission—beginning students.

Applicants for admission to regular status. Such applicants must have successfully completed three-fourths of the work acceptable for a bachelor's degree (usually 90 semester units) at a recognized institution of collegiate grade with an average at least equal to the average required for graduation in the institution attended.

Applicants for admission to special status. A limited number of applicants who cannot qualify for admission for regular status, will be considered for admission as special students. Such applicants must be over 23 years of age and must take the Law School Admission Test (see below). No application for admission to special status will be considered until a score report has been received on the Admission Test.

2. Requirements for admission—advanced standing.

All applicants for admission with advanced standing must establish that they are in good standing at the Law School last attended and present proof of satisfactory completion of courses for which credit is requested at a law school approved by the American Bar Association. A minimum of two years' attendance is required of all students admitted to advanced standing.

3. All applications for admission are subject to approval by the Dean of the Law School and the Law Faculty Committee on Admissions. Applicants previously disqualified on account of low scholarship in another law school are not admitted.

Admission Procedures

All applicants for admission must file an application for admission on the form provided by the school and, at the time of filing, pay the application fee of \$5.00. Application must be sent to or filed with the Dean of the Law School. Applicants who have a bachelor's degree must file transcript from the college conferring the degree; applicants who have done any graduate study must, in addition, file transcripts of all graduate study. Applicants who do not have a bachelor's degree must file transcripts from *each* college attended. Applicants who have previously attended another law school must also file transcripts from each law school attended and, if the transcripts do not clearly establish that the applicant was in good standing, must procure a certification of good standing from the prior law school. It is the applicant's responsibility to make all arrangements necessary to obtain such transcripts, and the transcripts must be ordered sent directly from the issuing school to the Dean of the School of Law.

Application and transcripts must be on file prior to registration. If, for any reason, transcripts cannot be filed prior to registration, request must be made to the Dean for provisional admission pending receipt of transcript and transcripts filed within 20 days thereafter.

Applicants for admission to special status must, in addition to the above, file high school transcript, take the Law School Admission Test (see below) and order a copy of the score report sent the Law School. Applicants for admission to special status must have application and all supporting transcripts on file before August 10.

Law School Admission Test

The Law School Admission Test, administered by Educational Testing Service (ETS) is designed to measure aptitude for professional law study. It is required of all applicants for admission as special students and it is recommended to all persons contemplating the study of the law. Application to take the test and bulletin of information can be obtained from the law school or from ETS, 20 Nassau Street, Princeton, New Jersey. The test is given four times a year. Test dates announced for 1958 are: February 15, 1958, April 19, 1958 and August 2, 1958. Test centers have been established throughout the United States and elsewhere. In the San Francisco Bay area all tests are given each year at the University of California, Berkeley, and at Stanford University. Application to take the test must be on file at Princeton, New Jersey at least ten days before the examination date. A fee of \$10.00 is payable ETS for the examination. Applicants should take the earliest possible examination.

COURSE OF STUDY, SCHOLARSHIP, ATTENDANCE AND DEGREE REQUIREMENTS

- 1. The course of study for the degree of Bachelor of Laws is four years. A student admitted to the law school is expected to pursue a complete course of study for four consecutive years. Unless prior approval is obtained from the Dean, no student may
- (a) carry less than nine or more than ten units in any regular semester, or more than five units in any summer session;
- (b) take any course in the Law School, other than the prescribed program for his class and year;
 - (c) take any course in any other school;
- (d) receive credit for any course taken at any other school after admission to the Law School.
- 2. Requirements for the degree are completion of 84 units of study in accordance with the prescribed curriculum with an average grade of C plus or better, and completion of a course in American History or evidence of satisfactory completion of such a course prior to entering Law School. This last requirement must be satisfied before admission to the fourth year of the Law School.
- 3. Classes meet three evenings a week, usually Mondays, Wednesdays and Fridays, from 6:50 to 9:20 p.m. Occasionally, a fourth night is required for a short time during a semester.

The school year consists of two semesters of 18 weeks each and a summer session of nine weeks. The summer session is a required part of the school year during the first three years of instruction. Class sessions falling on school holiday are made up during the semester. Consult the college calendar, page 2, for session dates.

A student may commence the study of law at any session; students entering in the spring semester, will require 4½ years to complete the curriculum.

4. Grades

Commencing with the 1957 academic year, grades are issued and recorded in numerical form on a scale ranging from a maximum of 100 to a minimum of 40, with 70 the required average for good standing, advancement and qualification for degree, and 50 the minimum grade for which unit credit for the course will be allowed. A grade below 50 is an F or failure.

In year courses, only one grade is entered for the entire course.

No credit is given for any course in which a final grade of F is received. A student receiving a final grade of F in a course will be permitted to continue in the school only if his weighted point average for all courses completed, including the course or courses in which such F grade was received, exceeds the minimum required under Rule 5. A student so permitted to continue must remove the F grade by taking the next succeeding final examination in the course in which the F grade was received and by attaining a passing grade on that examination. The course grade, after such re-examination shall be the grade received on re-examination, but not higher than 70.

No course completed in the Law School may be repeated.

5. Requirements for continuance and advancement

A weighted average of 70 or better is required for each year's work, as well as for all work completed, in order to maintain satisfactory status and progress. No student will be permitted to continue in the school after the completion of 54 units of studies, or to enroll for courses the unit value of which would, when added to work already completed, total more than 62 units, unless he has a minimum average of 70. Prior to the completion of 54 units of studies, a student with an average below 70 may be permitted to continue on probationary status, but only if he meets the following minimum standards: upon the completion of 18 units of studies, an average of 66.6; upon the completion of 36 units of studies, an average of 68.3.

6. Examinations. A final examination is given in each course; mid-year and other examinations are given when and as the instructor may announce. The extent to which mid-year examination grades, class papers and class work will be considered in determining the final grade is left to the discretion of the instructor in the course. All examinations must be taken on the date scheduled, unless for good cause shown, permission is obtained from the instructor and the Dean to take the examination at some other time. A student failing to take a final examination when scheduled or as so permitted, will receive an F in the course. A student failing to submit any papers required in the course will receive an incomplete in that course. An incomplete must be removed by submitting such work as was, or may be required by the instructor, within two weeks after the close of the course and if not so removed, a grade of F will be entered. A fee of \$5.00 is charged for any examination taken on other than the scheduled date and for any re-examination.

7. Attendance, Withdrawals, Leaves of Absence. A student may be dismissed at any time if, in the opinion of the faculty, his attendance at classes is so irregular that there is reasonable grounds to believe that he is not faithfully and diligently pursuing his studies. Three consecutive absences in any course will be grounds for dropping the student from that course unless leave of absence has been granted. Application for leave of absence should be made to the office of the Dean in advance of any contemplated absence of more than one week; in cases where the absence of a student is due to an emergency which prevented application for leave in advance, notification and request for leave shall be made at the earliest opportunity. A student dropped from more than one course for non-attendance will be dismissed from the school.

A student who, for good cause, is unable to complete a semester or year's work, or is unable, after completion of his course for a semester or a year, to return for the next regular semester, must, in order to retain his right to return, apply for and obtain a leave of absence. A student who withdraws during, or at the end of any semester, without first obtaining a leave of absence, will be re-admitted only upon application and in the discretion of the faculty. No leave of absence will be granted for longer than one year.

8. A student who, at the time of withdrawal, has not paid in full his current charges for tuition and other fees, cannot be granted an honorable dismissal or statement of work completed until all outstanding charges are paid. Students attending under the G.I. Bill, who withdraw from school during the semester, are required to return their books to the College bookstore.

9. Prizes.

The Bancroft-Whitney Company, Bender-Moss and The Recorder Printing and Publishing Company offer annual prize awards to members of the graduating class for scholastic achievement.

10. State Bar Rules and Regulations

Copies of the Rules Regulating Admission to Practice Law in California are available in the Dean's office.

Registration. Rule V, section 52, requires registration with the State Bar within three months after beginning the study of law. Registration forms are available in the Dean's office.

First Year Examination. Rule VI, sections 61-64, requires that every person admitted to any law school who had not completed two years of college study (as defined in that Rule) before entering the law school must take the first year law student's examination. This examination is given each year, usually on the last Monday in June. Application must be filed not less than two nor more than six months prior to the examination date. Application forms are available in the Dean's office.

Courses of Instruction

The credit value of each course is indicated in total units by the number in parentheses after the course title; the semester or semesters in which the course is given are indicated as follows: I, fall semester; II, spring semester; Yr., both fall and spring semesters; SS., summer session; the summer session at the end of the first year is part of the first year curriculum.

FIRST YEAR

Contracts (6) Yr.

Mr. Smith, Mr. Moore

Formation of contracts; offer and acceptance; consideration; assignments; third party beneficiaries; statute of frauds; legality; performance; discharge.

Criminal Law (3) II

Mr. Snow, Mr. Roddis

The elements of and defenses applying to criminal acts in general; various specific crimes; criminal procedure.

Introduction to the Study of Law (3) I and II Miss Sherburne, Mr. Hannawalt

This course is given in each semester and is required for all students beginning the study of law at that semester. It is an introductory course designed primarily to train beginning students in the legal skills necessary to the proper use of legal materials, case law and statutes. Among the subjects considered are: courts and court organization, procedure and its importance, analysis of cases, the development of case law by synthesis of decisions, and the interpretation of statutes. The course also includes a consideration of the role of the Legal Profession in society.

Personal Property (2) SS

Mr. Smith

Possessory interests in and methods of acquiring ownership of and possessory and security interests in chattels.

Torts (6) Yr.

Mr. Paul, Mr. Gorfinkel

The law of civil injuries, including intended and unintended interference with personal and property interests and liability without fault.

Second Year

Business Associations (6) Yr.

Mr. Moltzen

A consideration of the legal problems of business organizations, including partnerships, corporations and other forms of multiple ownership and operation of business enterprises.

Commercial Law (6) Yr.

Mr. Smith

Negotiable Instruments: Types and function; elements of negotiability; negotiation; rights and liabilities of parties. Sales: Passage of title; statutory and contractual devices for protection of sellers and financing agencies; protection of bona fide purchasers; warranties.

Real Property (6) Yr.

Mr. Taubenfeld

First semester: Possession; the modern land transaction, including contracts of sale, mortgages and deeds; estates in land; landlord and tenant. Second semester: the modern land transaction resumed, recording acts; control of the use of land, covenants, easements, licenses and rights of support.

Third Year

Constitutional Law (6) Yr.

Mr. Gorfinkel

The judicial function in constitutional cases; the division of powers between the federal government and the states; separation of powers within the branches of the federal government; the protetion of individual rights and liberties.

Evidence (6) Yr.

Mr. Poole

The problems of proof and the use, adequacy and admissibility of oral testimony and documentary materials in trials before judicial and administrative tribunals.

Equity (6) Yr.

Mr. Taubenfeld

The origins, historical development and the present significance of equity jurisdiction, procedures and remedies.

Fourth Year

Conflict of Laws (3) H

Mr. Hannawalt

A consideration of the legal principles concerning jurisdiction to adjudicate, enforcement of foreign judgments and causes of action and choice of law in legal situations involving citizens or laws of more than one state or country.

Community Property (2) II

Mr. Jordan

A study of the rights of the respective spouses in their property with special emphasis on the California law.

Taxation—Estate and Gift (2) II

Mr. Barry

A detailed study of the Federal Estate and Gift Taxes and a consideration of the principal features of the California Inheritance and Gift Taxes.

Taxation—Income (3) I

Mr. Walker

A detailed study of the Federal Income Tax.

Trusts (3) I

Mr. Barry

Creation of trusts by agreement or by operation of law; the rights, duties and obligations of parties to the trust; formalities for creation of trusts; legality as affected by the terms or purposes of the trust.

_ ...

Practice and Procedure (6) Yr.

Mr. Courter

The elements of civil procedure and trial practice; jurisdiction and venue; parties to civil actions; nature, form and sufficiency of pleadings in civil actions; special proceedings and provisional remedies. Special emphasis is placed on the provisions of California law.

Seminar in Selected Legal Problems (2) I or II The Staff, Mr. Gorfinkel in charge

Individual research in selected legal problems. Prerequisites: Admission to the fourth year of law school and approval of the Dean.

Administrative Law (2)

Mr.

The principles of law governing the organization and authority of administrative agencies in rule making and adjudication, and judicial review of administrative rulings and decisions.

Domestic Relations (2)

Mr.

The law respecting various aspects of family status, including marriage, divorce, annulment and separation; rights and obligations of parent and child; property and support rights and agreements.

Future Interests (2)

Mr.

The historical background and present treatment of future interests in property, with particular emphasis on class gifts, gifts by implication, rules against perpetuities and restraints on alienation, and the basic essentials for validity of transfers involving future interests.

Wills (2) Mr. Smith

Statutory provisions governing intestate succession; testamentary disposition; requisites for validity, revocation, revival and republication; essentials of probate procedure.

Writing and Research (2) The Staff, Miss Sherburne in charge
