On Tuesday, March 14, Golden Gate University School of Law presents the annual Public Interest Law Foundation (PILF) Fundraising Auction. PILF is a non-profit student run organization that assists law students pursuing careers in public interest law.

Admission ticket includes food and beverages. There is no charge to attend the silent auction.

Golden Gate University's law students and alumni have a long history of providing essential legal services and creating positive social change in the Bay Area and beyond. The PILF Auction raises money to fund grants that enable students to gain invaluable legal experience while interning at organizations that provide representation to underserved individuals and communities. Previous PILF grant recipients have worked on juvenile justice issues, domestic violence, elder abuse, legal challenges related to HIV/AIDS, environmental law, and many more. Because law students must contend with increasing tuition and higher debt loads, few can afford to accept unpaid public interest internships without significant financial assistance.

Thanks to the generosity of the legal community and Golden Gate University law faculty and alumni, last year's PILF Auction raised over \$26,000. This money funded 21 students working at public interest jobs. This year, PILF's goals are even loftier. We
