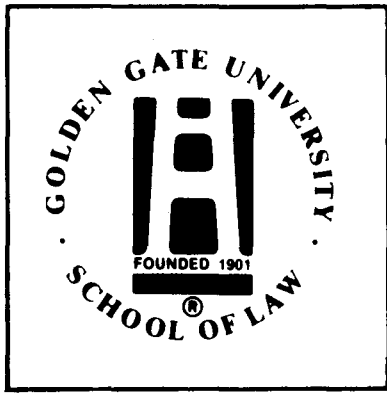

Law Alumni Association Forms

The newly-formed Law Alumni Association staged its second event in two months on April 28 when 14 alumni serving in various judicial capacities were honored at the Judges' Night Reception. Co-sponsored by the School of Law, the event drew alumni and students to meet the judges and to view the photographs of GGU Law alumni on the bench which Dean Anthony J. Pagano had assembled and displayed in the Moot Court Room.

A Steering Committee composed of 12 Law alumni has been working actively with the Alumni Office to form the association. The basis for both the association and the Steering Committee was a survey of interest sent to a random sample of 500 Law School graduates in October 1988. The majority of alumni responding indicated that the primary focus of a Law Alumni Association should be "to strengthen the reputation of the School and its graduates," and an overwhelming majority favored annual dues to support the association in the amount of \$25.

Top program choices selected by survey respondents were events that featured Golden Gate's Law alumni on the State Bar Board of Governors, which was sponsored by the Law Alumni Association on March 16, and the Judges' Night Reception on April 28. In addition to staging events that bring students and alumni into contact with outstanding graduates, the association plans to investigate the possibility of producing educational events which would offer updates in specific areas of legal

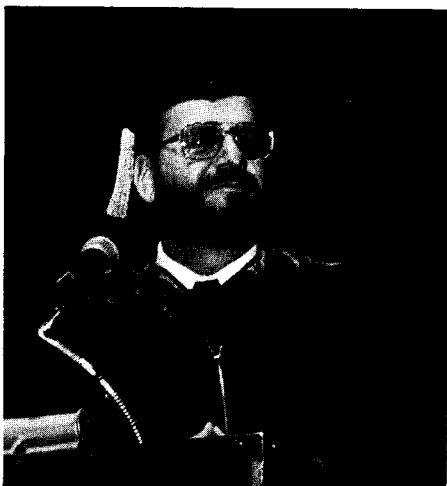

1989 McKelvey Award Winners Announced

Philip Pro (Class of 1972) and Susan Hestor (Class of 1976) were honored at 1989 graduation ceremonies as the 1989 recipients of the Judith G. McKelvey Award.

Philip Pro has been a U.S. District Judge in Las Vegas, Nevada since 1987, where he is known for his fairness and judicial demeanor. Previously he had been United States magistrate in Las Vegas; when appointed he was 33 years old, which made him one of the youngest full-time magistrates in the United States at the time. As magistrate, he worked on a number of extremely complex cases, including one of the largest mass disaster lawsuits in the country that grew out of the 1980 MGM Grand fire. He has also served as Chief Assistant United States Attorney in Reno, Deputy Attorney General in Carson City, Assistant United States Attorney in Las Vegas, Deputy Public Defender in Las Vegas, and was in private practice for a year in general civil and criminal law.

Phil has a strong commitment to public service and has served on numerous law-related committees, including as a member of the State of Nevada's Commission on the Bicentennial of the United States Constitution, President of the Nevada American Inn of Court (1988-89), member of the Ninth Circuit Judicial Council's Jury Instruction Committee, and Chairman of the National Conference of Christian and Jews Issues in Justice Forum. He has taught many Continuing Legal Education courses and was the recipient of the Award of Special Recognition by the State Bar of Nevada in 1984. He lives in

Las Vegas with his wife and daughter.

Named one of the ten most powerful people in San Francisco by *San Francisco* magazine, land-use attorney Sue Hestor has been involved in the drafting of and campaigning for every growth control and district election initiative in San Francisco since 1971. She had major responsibility for Proposition M in 1986, which established development priorities for San Francisco and limited

the amount of office space that could be constructed annually.

After graduation from GGU, she worked for three years as a staff attorney for the San Francisco School District on its desegregation program. For the past nine years, she has run a one-person law office specializing in environmental and land use issues and affordable housing. While best known for her battles against high-rise office buildings, Sue has also been involved in the fight for low cost housing and the preservation of community services in San Francisco. She is currently involved in an environmental suit against the Livermore Lab and in community and legal efforts to make Hastings Law School accountable for the housing it has taken out of the market.

The McKelvey Awards were established in the name of Professor Judith G. McKelvey, former dean of the Law School, and honor outstanding achievements by Golden Gate Law School alumni.

National Bar President James Cole 1989 Commencement Speaker

James O. Cole, attorney and Division Counsel for the Household Products Company, a wholly-owned subsidiary of The Clorox Company, spoke to the 1989 graduating class on Saturday, May 27, in commencement ceremonies at the Masonic Auditorium in San Francisco. Cole is currently president of the National Bar Association and immediate past chair of the Commission on Judicial Nominees Evaluation. He is also past president of the Charles Houston Bar Association and of the California Association of Black Lawyers. He also serves on the boards of directors of various Bay Area organizations, including the Wiley Manuel Law Foundation, the Bay Area Urban League, the Black Filmmakers Hall of Fame, the Oakland Ballet and the College Preparatory School.

Cole is a 1971 graduate of Harvard Law School and of Talladega College in Alabama. He has lived and worked in the Bay Area for the last 15 years. At the 88th annual commencement he addressed 125 graduating students on "The

Role of Attorneys in Today's Society." In a recent interview with Francesca Bannerman in the *Daily Journal*, Cole identified his goals for the National Bar Association. During his tenure as president he plans to "work with other bar organizations to increase opportunities for minority lawyers," in addition to increasing membership recruitment efforts. The NBA has 12,000 members and is the nation's largest minority bar association.

Johnson Scholarship Endowed by Trustees

The Richard W. Johnson Memorial Scholarship was given official endowment status by the University's Board of Trustees at its April meeting. The scholarship had been in existence since November 1967 when it was established by Johnson's friends from the Class of 1965, following his death in an automobile accident. A recent fund drive headed by alumni friends of Johnson—Judge Norman Spellberg, Gordon Reynolds, Dennis O'Brien and Bill Lentz—raised enough money to bring the scholarship total to the \$10,000 required for endowment.

Rich Johnson, after a disappointing academic start his first year, became a top student and the scholarship in his memory reflects these circumstances. It is to be awarded to a student who has been either on probation or close to it his or her first year, and who makes the

biggest improvement during the second year of law school. The scholarship will be awarded in the fall semester following the recipient's second year.

Upon his graduation, Rich Johnson formed a partnership with Edward Merrill, now a Contra Costa Superior Court Judge. Early in 1967, while driving a baby sitter home, Johnson was killed in an accident involving a drunk driver. He was 35. He is survived by his second wife, Priscilla, and his son, Mark.

Classmates of Rich Johnson's who are Charter Donors to the Memorial Scholarship include Roy Y. Powlan, Barbara Goldeen, Sam Goldeen, Martin Hineser, Joseph Neri, Leo Paoli; and Spellberg, Reynolds, Lentz and O'Brien. A plaque in his memory will be placed in the School of Law.

Faculty NEWS

In March, Golden Gate University's constitutional law clinic, under the leadership of Professor **Mort Cohen**, filed a civil suit in San Francisco Superior Court to order statewide regulations protecting the right of nursing home patients to decide on the use of mind-altering drugs in the absence of an emergency, or to have a relative make the decision if the patient cannot. The suit was brought on behalf of Bay Area Advocates for Nursing Home Reform and Donna M. Gilmour, whose 84-year-old father died shortly after being given an anti-psychotic drug in a nursing home. Mort was quoted in *The New York Times* as saying, "It is ironic that we are fighting a drug war in the streets, while in nursing homes no one is given the opportunity to know what drugs they are being given and why."

Professor **Janice Kosel** will be on leave next year—she will be teaching at Santa Clara University School of Law.

Visiting Professor **Richard D. Lee** has recently been hired by the firm of Morrison & Foerster to be director of professional development. According to *California Lawyer*, this is the first time a San Francisco law firm has hired an attorney to work full time on in-house training.

In April, Professor **Thomas Goetzl**

held workshops on Art Law at the College of Santa Fe, and at the California College of Arts and Crafts. He also spoke at the Northern California Association of Law Libraries' Visual Arts and the Law Institute, and was a featured speaker at the New Mexico Association of Museums' annual meeting in Gallup, New Mexico. There he led a workshop on "Legal Problems of Museum Administration," and spoke on "Museums and the Law."

Professor **Myron Moskovitz** has a new book out entitled *Cases & Problems in Criminal Law*. It was published in April by Anderson Publishing Company.

This summer, Professor **Marc Stickgold** visited the People's Republic of China on an invitation from the U.S. Embassy and the law faculty at People's University to discuss issues of legal education and constitutional law. His article, "The Invisible Curriculum: Clinical Fieldwork in American Law Schools," will appear in the forthcoming New Mexico *Law Review* as part of a national ABA symposium on professional training skills.

Assistant Dean **Elaine Andersson** spent three days in April in Chicago working with the ABA's Silver Gavel Awards Screening Committee. These awards, given at the ABA's annual convention, honor books, magazines, newspapers, television and films that advance the public's understanding of the law and the legal profession. In addition, she will serve as co-chair of the 1989-90 Nominations Committee. This working committee will be responsible for selecting and submitting names of Law School Records and Admission personnel from around the country as nominees to replace outgoing members on the Executive Board of Directors whose terms will expire in April 1990.
