**School of Law Professors Available To Discuss Today's California Supreme Court Ruling Upholding Proposition 8 Banning Same-Sex Marriage and Confirming Validity of Same-Sex Marriages Conducted before November 2008 Election**

**Associate Professor Eric Christiansen** teaches Constitutional Law and has published widely on constitutional legal issues. He is one of two Golden Gate University Law School professors to sign an amicus brief that was submitted to the California Supreme Court concerning the challenge to Proposition 8. As a gay man married in California earlier this year, Professor Christiansen has a unique perspective on the legal and civil rights implications of the ruling. **Professor and Dean Emeritus Peter Keane** is a frequent media commentator on legal issues, particularly pertaining to California law and policy. He served as chief assistant public defender in the San Francisco Public Defender's Office for nearly two decades and is a former member of the San Francisco Police Commission, former vice president of the State Bar of California, and former president of the Bar Association of San Francisco. He authored California's Proposition 190, which amended the California Constitution and reformed the State Commission on Judicial Performance.
