> "The Bar and the courts are becoming increasingly aggressive in seeking to influence the curriculum of law schools. The Second Circuit has adopted the Clair Committee proposals to require the taking of five named courses for elibibility for admission to the Bar of the Circuit. The Indiana Supreme Court has required 54 hours of desigrated courses in order to be admitted to the practice of law in that state."
