

## CURRICULUM FOR STUDENTS BEGINNING IN JANUARY

TUDENTS beginning the study of law in January take a four and one-half year course, completing their work in May, 1944. The first semester and the last semester are conducted on a lighter schedule than the rest of the course. Thus the regular four-year course has been spread over four and one-half years, making it easier to get started and adjusted to the study of law in the first year, and providing a lighter schedule at the end when the student should be spending considerable time reviewing in preparation for the bar examination. Since there is only one bar examination a year, in October, there is no reason for rushing through the course in four years and finishing in December. It is our belief that the January schedule is ideal, since it gives the student a longer time to assimilate the course. During the spring and summer the student will study the Law of Torts, one of the most fundamental of all legal subjects. Classes will meet on Monday and Friday evenings, 6:30-9:30 p.m. This course is completed by May 31. From June 3 to July 12 Personal Property will be given on Monday, Wednesday and Friday evenings. After five weeks of summer vacation, class work resumes on August 19, meeting three times a week, Monday, Wednesday and Friday, from 6:30 to 9:30 p.m. It continues on this schedule during the fall and spring semesters and the summer session until December, 1943. During the spring semester of 1944, the student would complete his course in Practice on Wednesday evenings, using the rest of his time for review. He would graduate in May, 1944, and take the bar examination in October of that year.

#### Accreditation

The School of Law of Golden Gate College fulfilled the requirements for accreditation by the State Bar Association during the fall of 1939. As a result, students of the school will be exempt from taking the first-year examination. The October, 1939, examination was the third consecutive examination in which the school has passed 50% or better. Four of the five graduates of June, 1939, have been admitted to practice, and the fifth is expected to pass the bar examination on his second attempt.
