Dear Friend:

From the outset of this legislative session, the Committee on Higher Education recognized the fundamental and serious consequences of the severe budget reductions imposed on our public colleges and universities. To respond to the challenge, we engaged in an intensive, broad-based reassessment of the landmark Master Plan for Higher Education. Through more than a dozen hearings, a statewide working conference, and a provocative set of draft recommendations that sparked spirited debate, we encouraged innovation, efficiency, and excellence.

Beyond the comprehensive consideration of the Master Plan, the Committee developed effective and thoughtful policy solutions for intractable problems facing higher education. We passed legislation to reform student financial aid priorities and delivery (AB 319, AB 1064, AB 1561, and AB 2227), end turf battles between high schools and community colleges over adult education programs (AB 1056), restore public confidence by making the institutional governing boards more accountable (ACA 11, ACA 20, and AB 2113), and fulfill the state's funding committment to community colleges (AB 973 and AB 3474).

Our Subcommittee on Workforce Training, Development, and Educational Support looked to the future of California's economy and refocused the attention of legislators and educators on preparing our citizenry for the jobs of tomorrow (AB 486, AB 2774, and AB 2775), while several of our members worked to implement the new National Service Program in California (AB 606, AB 1104, AB 1077, and AB 2080).

Much of the legislation passed during the session represented major new initiatives in difficult policy areas; as a result, many of the bills failed to win approval of the Senate or the Governor. However, the proposals, like the problems they were designed to correct, will remain before the Legislature, and we expect these initial efforts to form the basis of further legislative deliberation in coming sessions.

Adult Education

AB 1056 (Alpert)

Requires all school districts and community college districts to enter into formal, written delineation-of-function agreements for the operation of adult education programs in each geographic region. Protects adult education programs in operation on January 1, 1994, from transfer or elimination without the agreement of the operating district (grandparenting all existing programs), and establishes an appeals and arbitration procedure in the event that a school district and a community college district cannot reach a delineation agreement. In addition, withdraws authorization for school districts to contract with private vocational institutions for adult vocational skills services.

Vetoed by the Governor

AB 2527 (Napolitano)

Adds the establishment of noncredit citizenship courses for persons eligible to become citizens to the list of educational goals for distance learning and declares the intent of the Legislature that the 605 Corridor Citizenship Project in the eastern Los Angeles region serve as a model distance learning program for courses of this type.

Vetoed by the Governor

Budget & Finance

AB 596 (Murray)

Changes the formula through which community college districts compute fundable enrollment growth to the greater of: a) the combined average rate of growth in adult and high school age population, and unemployment; b) 150 headcount students or 100 full-time equivalent students; or c) 1% growth. Any additional growth funds would be allocated for expansion of service to districts with low participation of adults in the community college instructional program. If insufficient funds are available to fund computed growth, all districts' growth rate would be reduced proportionately.

AB 715 (Burton)

Specifies that the minimum increase in funded enrollment growth for an individual community college district shall be

	equal to the statewide adult population growth rate or one percent of the district's funded enrollment, whichever is greater.

AB 752 (Murray)	States legislative intent that the Charles R. Drew University of Medicine and Science be funded at a level that reflects inflationary cost increases to the institution between the 1982-83 and 1993-94 fiscal years.

AB 973 (Bornstein)	Appropriates \$56.5 million from the General Fund to the California Community Colleges to offset the shortfall in property taxes received during the 1993-94 fiscal year.
	Chapter 142, 1994
AB 1709 (Farr)	Excludes from the community college apportionment obligation calculation 70 percent of any fee revenue collected from students for whom no apportionment funds are provided.
	Held on Assembly Ways and Means Suspense File
AB 1724 (Farr)	Delays for one year the three-year phased reduction in funding related to declines in enrollment for community college districts that experience a loss of enrollment due to the closure of a military base.
	Held in Senate Education
AB 1745 (Farr)	Increases the state apportionment rate for noncredit stroke rehabilitation classes at community colleges from the noncredit rate to the credit rate.
	Vetoed by the Governor
AB 3474 (O'Connell)	Establishes the state apportionment rate for community college districts at an absolute level in any fiscal year by automatically 1) appropriating General Fund moneys sufficient to offset any

ACA 25 (Woodruff)	Proposes to the voters a constitutional amendment to expand the funding provisions of Proposition 98 to include CSU and UC, and allocates state revenues in excess of the Gann expenditure limit to CSU and UC, in addition to K-14 education, in proportion to total public education enrollment.
	Held in Assembly Elections, Reapportionment & Constitutional Amendments
SB 323 (Lewis)	Authorizes the CSU Trustees to use parking fine and forfeiture revenue to support course offerings at off-campus centers to mitigate the impact of student and employee parking and transportation on the main campus and surrounding community.
	Failed Passage in Assembly Higher Education
SB 399 (Hart)	Provides the necessary statutory changes to implement the 1993 Budget act relative to K-14, provides CCC with a loan of \$178 million, and increases student fees from \$10 per unit to \$15.
	Chapter 66, 1993
SB 418 (Morgan)	Authorizes CPPVE to adopt fee schedules by January 1, 1995, which include amounts of penalty fees for delinquent payments. The Council would be authorized to add or delete categories of the fee schedule based on work performed by the Council.

AB 2967 (Committee on Higher Education) Enacts the "Higher Education Emergency Earthquake Recovery Act of 1994" to provide non-facilities related relief to CSU Northridge and Antelope Valley, Los Angeles, Santa Clarita, Santa Monica, and Ventura Community College Districts following the 1994 Northridge Earthquake.

Chapter 957, 1994

AB 3120 (Archie-Hudson) Requires each campus of the UC and the CSU to develop and file with the Office of Emergency Services a disaster response and recovery plan, and to assess the feasibility of creating regional disaster response and recovery plans.
