**ADMINISTRATIVE PROCEDURE ACT (APA)**

**AB 12 (Cooley) State government: Administrative Procedure Act: standardized regulatory impact analyses.**

Requires the Department of Finance and the Office of Administrative Law (OAL) to review annually the standardized regulatory impact analyses for adherence to the regulations adopted by a state agency, and report back to the Legislature; requires the legislative report to include any recommendations improving state agency performance and compliance; and requires the OAL to post the report and notice of noncompliance on the Internet.

Last Action: Vetoed

**AB 292 (Nestande) California Code of Regulations: open access.**

Requires the full text of the California Code of Regulations to have an open access creative commons attribution license to allow any individual, at no cost, to use, distribute, and create derivative works based on the material for either commercial or noncommercial purposes.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**AB 376 (Donnelly) Regulations: notice.**

Requires a state agency that enforces a regulation promulgated on or after January 1, 2014, to notify a business that is mandated to comply with the regulation 30 days before the regulation becomes effective.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**AB 866 (Linder) Regulations.**

Reduces the economic impact threshold for defining a major regulation, for purposes of the Administrative Procedure Act, from \$50 million to \$15 million and modifies the requirements that an adopting agency must meet when preparing the economic impact analysis and the standardized regulatory impact analysis.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**AB 1105 (Hueso) Administrative practices.**

Requires state agencies that are proposing building standard regulations to include information about the regulation's estimated costs to comply, potential benefits, and assumptions used to determine estimates.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**AB 1415 (Accountability and Administrative Review Committee) Administrative Procedures: regulations: determinations: judicial review.**

Bill was substantively amended and was no longer authored by the Committee.

---

**AB 1612 (Donnelly) State government: regulations.**

Prohibits the Office of Administrative Law from charging any fee to individuals with disabilities to enable access to the California Code of Regulations, and from charging for any accessibility option advertised to end users of its Internet Web site under the "accessibility" link, as specified.

Last Action: Vetoed

**AB 1706 (Jones-Sawyer) State government: Administrative Procedure Act: standardized regulatory impact.**

Requires that an already-required report to the Legislature about standardized regulatory impact analyses for proposed major regulations include information on the cumulative economic impact of the regulations on businesses within the state.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**AB 1711 (Cooley) Administrative Procedure Act: economic impact assessment.**

Requires an economic impact assessment to be included in the initial statement of reasons that a state agency submits to the Office of Administrative Law when adopting, amending, or repealing a non-major regulation.

Last Action: Chapter 779, Statutes of 2014

**AB 2723 (Medina) Administrative procedure: small businesses.**

Makes clarifying changes to the Administrative Procedure Act to include "sole proprietorships" and "small business" in the required standardized regulatory impact analysis when a state agency proposes to adopt, amend, or repeal a *major* regulation.

Last Action: Vetoed

**ACA 1 (Donnelly) Administrative regulations: legislative approval.**

Amends the California Constitution to require state agencies to submit all regulations that have been approved by the Office of Administrative Law to the Legislature for final approval.

Last Action: Failed passage in Assembly Accountability and Administrative Review Committee

## **GOVERNMENT EFFICIENCY**

### **AB 117 (Cooley) State government: financial and administrative accountability.**

Makes specified legislative findings and directs the Department of Finance to establish guidelines for agencies to ensure proper internal monitoring, accounting, and administrative controls within these agencies.

Last Action: Chapter 193, Statutes of 2013

### **AB 1218 (Gray) The California State Auditor: duties.**

Clarifies existing law by explicitly authorizing the California State Auditor, after performing an audit, to conduct follow-up audit work that is related to the audits' original findings and recommendations.

Last Action: Chapter 189, Statutes of 2013

### **AB 1305 (Gray) The California State Auditor: duties.**

Requires the California State Auditor to conduct annual audits of five state departments, based on a methodology developed by the CSA, in addition to audits required by statute or requested by the Legislature.

Last Action: Held in Assembly Accountability and Administrative Review Committee

### **AB 2253 (Ting) Bilingual services: implementation plans.**

Requires state agencies that serve a substantial number of non-English speakers, as defined, under the Dymally-Alatorre Bilingual Services Act to provide translated forms and processes for submitting complaints about language access.

Last Action: Chapter 469, Statutes of 2014

## **GOVERNMENT ORGANIZATION**

### **AB 291 (Nestande) California Sunset Review Commission.**

Abolishes the Joint Sunset Review Committee on January 1 of an unspecified year and replaces it with the California Sunset Review Commission, as specified.

Last Action: Held in Assembly Accountability and Administrative Review Committee

### **AB 481 (Lowenthal) High-speed rail.**

Grants the High-Speed Rail Authority similar property management authority as that granted to the California Department of Transportation.

Last Action: Chapter 132, Statutes of 2013

### **AB 554 (Mullin) State government: Secretary of State: fees.**

Changes accounting procedures for the Business Fees Fund at the Secretary of State, and establishes a new account for deposit of a portion of funds from the existing corporate disclosure fee.

Last Action: Chapter 364, Statutes of 2013

### **AB 650 (Nazarian) State government: general services: Natural Gas Services Program.**

Establishes parameters for the Natural Gas Services Program and requires most executive branch agencies to purchase gas through the Program.

Last Action: Chapter 615, Statutes of 2013

### **AB 661 (Beth Gaines) State government: FISMA.**

Adds posting, reporting, and guidance requirements under the Financial Integrity and State Manager's Accountability Act of 1983 (FISMA), and sets consequences for noncompliance. Requires the head of the agency to sign off on FISMA reports under penalty of perjury and suspends the head of the agency without pay if the reports are not submitted within 30 days of their due dates.

Last Action: Held in Assembly Appropriations Committee

### **AB 962 (Harkey) State government: survey of local assessment procedures.**

Modifies reporting requirements of the State Board of Equalization (BOE) regarding surveys conducted by the BOE of the procedures, practices, and general performance of county assessors.

Last Action: Held in Assembly Accountability and Administrative Review Committee

### **AB 1317 (Frazier) State government operations.**

Makes necessary and conforming changes in the statutes to properly reflect the assignment and reorganization of the functions of state government as required by the Governor's Reorganization Plan 2.

Last Action: Chapter 352, Statutes of 2013



**AB 2138 (Gatto) Innovation awards.**

Creates a one-year “innovation awards” contest in state government for the purpose of awarding cash prizes to eligible California participants who are not employees of the state.

Last Action: Chapter 678, Statutes of 2014

**AB 2200 (John A. Pérez) California Cyber Security.**

Creates the California Cyber Security Steering Committee in the Governor’s Office of Emergency Services; continues in existence the California Cyber Security Task Force; and requires the Committee to seek to implement the policy recommendations of the Task Force.

Last Action: Held at Assembly Desk

**AB 2221 (Campos) Business Filing Coordination Council.**

Establishes the Business Filing Coordination Council within the Secretary of State’s office.

Last Action: Vetoes

**AB 2328 (John A. Pérez) California AmeriCorps.**

Establishes California AmeriCorps to be administered by California Volunteers, within the Governor’s Office, and operated under existing federal AmeriCorps program guidelines.

Last Action: Vetoes

**AB 2523 (Cooley) Department of Technology.**

Requires the Director of the Department of Technology to review a specified project management methodology manual and, based on that review, provide a report to the Legislature by July 1, 2016, recommending how a team of senior consulting information technology (IT) experts can assist senior department executives charged with oversight of major IT projects.

Last Action: Chapter 391, Statutes of 2014

**AB 2763 (Accountability and Administrative Review Committee) State government operations.**

Makes additional changes in the statutes necessary to reflect the changes made by the Governor’s Reorganization Plan 2 as introduced to the Legislature on May 3, 2012, and made effective on July 2, 2012. Reallocates specified duties of reorganized and abolished state entities and their officers to established state entities.

Last Action: Chapter 401, Statutes of 2014



## **OVERSIGHT**

### **AB 1365 (John A. Pérez) State and local agency reports: Legislative Counsel.**

Makes substantive and clarifying changes to existing law relating to reports filed by state and local agencies with the Legislative Counsel as well as pertaining to the requirement that the Legislative Counsel prepare and maintain an electronic list of all reports.

Last Action: Chapter 192, Statutes of 2013

### **AB 1420 (Accountability and Administrative Review Committee) State government: state agencies: reports.**

Eliminates and modifies certain state agencies' reporting requirements to the Legislature, Governor and other state agencies in order to address conflicts with certain provisions of SB 71 (Leno, Chapter 728, Statutes of 2012) that eliminated a number of obsolete reporting requirements for state agencies and departments.

Last Action: Chapter 275, Statutes of 2013

### **AB 1578 (Pan) Online database: expenditures: service contracts.**

Bill was substantively amended to a new subject area outside of committee's jurisdiction.

### **AB 1583 (Allen) Controller reporting: State funds.**

Requires the State Controller's Office to include specified information in the budgetary-legal basis annual report on all funds maintained in accounts outside the State Treasury System.

Last Action: Chapter 230, Statutes of 2014

### **AB 2037 (Accountability and Administrative Review Committee) Environmentally preferable purchasing.**

Requires the Department of General Services to track environmentally preferable purchases by state agencies and publically report information about these purchases.

Last Action: Held in Assembly Appropriations Committee

## **PUBLIC CONTRACTS**

### **AB 1586 (Holden) Public contracts: hiring: priority consideration.**

Expands the requirements for providing priority hiring consideration for state contracts for services exceeding \$200,000 by requiring contractors to consider all qualified job applicants that receive or have exhausted unemployment insurance benefits; or, reside in specified targeted employment areas when filling vacancies funded by the contract.

Last Action: Vetoed

### **AB 1705 (Williams) Public contracts: payment.**

Clarifies the circumstances under which a public agency may retain more than 5% of a contract price until final completion of a substantially complex public works project.

Last Action: Chapter 670, Statutes of 2014

### **AB 1773 (Allen) Public contracts: courts.**

Revises reporting requirements related to contracting activities by judicial branch entities.

Last Action: Held in Assembly Appropriations Committee

### **AB 2022 (Medina) Public contracts: Target Area Contract Preference Act.**

Changes the Target Area Contract Preference Act by redefining what qualifies as an economically distressed area.

Last Action: Chapter 780, Statutes of 2014

### **AB 2471 (Frazier) Public contracts: change orders.**

Requires state and local public entities engaged in a public works contract awarded to the lowest bidder to promptly issue change orders when extra work is required of the contractor or subcontractor.

Last Action: Held in Senate Appropriations Committee

### **AB 2682 (Wagner) Responsible and reliable parties.**

Requires the Department of General Services to adopt regulations to exclude potential contractors from state contracts based on contractors' poor performance or past violations.

Last Action: Held in Assembly Accountability and Administrative Review Committee

## **STATE PROCUREMENT**

### **AB 173 (Weber) Postsecondary education: Small Business Procurement & Contract Act.**

Authorizes the California Community Colleges and the California State University to award a contract with a value greater than \$5,000 but less than \$250,000 for the acquisition of goods, services or information technology without competitive bidding, to a certified small business (SB) or a disabled veteran business enterprise (DVBE), if the institution receives a price quote from two or more of these entities. Allows the University of California (UC) to award contracts for the acquisition of goods, services, or information technology that have an estimated value of between \$100,000 and less than \$250,000 to a certified SB or a DVBE if UC obtains price quotations from two or more certified SBs or two or more DVBEs and the UC Regents authorize an enacting resolution.

Last Action: Chapter 262, Statutes of 2013

### **AB 199 (Holden) Institutional purchasers: sale of California produce.**

Requires all California state-owned or state-run institutions, except public universities, public schools, and school districts, to purchase agricultural products grown in California before those that are grown outside the state as long as the price is the same or less than out-of-state products. Encourages all public universities, public schools, and school districts in California to purchase agricultural products grown in California to the greatest extent possible.

Last Action: Vetoed

### **AB 682 (Ian Calderon) State procurement: food: plumped poultry.**

Prevents the purchase of chicken or turkey sold or served in public school facilities or state-owned or leased buildings for food concessions, cafeterias, or vending operations from being "plumped," as defined, in any way.

Last Action: Held in Assembly Appropriations Committee

### **AB 963 (Levine) State contracts: request for proposal: procedures.**

Requires state agencies to select the bidder with a record of environmentally preferable purchasing instead of the lowest bidder without this designation, as long as the lowest bid was not more than three percent less than the bidder with the environmentally preferable purchasing record.

Last Action: Held in Assembly Appropriations Committee

### **AB 1212 (Levine) Public contracts: bids: "or equal" materials or service.**

Prohibits state agencies and other government entities from requiring bidders to provide information to substantiate that an item is considered "equal" prior to the bid or proposal submission deadline.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**AB 1353 (Linder) Public contracts.**

Defines who is required to be listed as a subcontractor when seeking bids for any public work or improvement project and requires an agency that is seeking bids for a public work or improvement project to provide in the specifications for the work a requirement that bids include the name and business location of each subcontractor.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**AB 1416 (Accountability and Administrative Review Committee) State government: property acquisition.**

Requires the State Public Works Board to annually notify the Legislature of a payment agreement or interest payment resulting from a property acquisition.

Last Action: Held on Senate Floor

**AB 1568 (Grove) Public contracts: direct quotes.**

Requires state agencies to solicit price quotes from at least three certified small businesses or disabled veteran business enterprises when awarding state contracts under \$250,000.

Last Action: Held in Senate Appropriations Committee

**AB 1574 (Pan) Personal services contracts: prohibitions.**

Prohibits a state agency from entering into a personal services contract that guarantees payments for services not provided.

Last Action: Vetoed

**AB 1575 (Pan) Personal services contracts: reports and termination of contracts.**

Requires contractors for personal services contracts to provide the state agency's contracting official with quarterly reports about performance and expenses, and sets criteria for contract termination.

Last Action: Vetoed

**AB 1734 (Jones-Sawyer) Public contracts: small business participation: disabled veterans.**

Requires each state agency to establish and achieve a goal of 25% small business participation and an annual phased-in goal of 5% disabled veteran business enterprises participation in state contracting.

Last Action: Held in Assembly Appropriations Committee

**AB 1921 (Holden) Personal services contracts: access to records.**

Requires a contractor who has a service contract with a state agency in excess of \$25,000 to agree that the state agency is entitled to receive a copy of records and files related to the performance of the contract, and specifies that such records may be disclosed under provisions of the California Public Records Act.

Last Action: Held in Senate Appropriations Committee

**AB 2011 (Daly) Information technology procurement: off-the-shelf software.**

Requires the Department of Technology to report to the Legislature on the effective use of off-the-shelf technology in information technology procurement.

Last Action: Held in Assembly Accountability and Administrative Review Committee

---

**AB 2620 (Rendon) State contracts: goods and services.**

Requires the Department of General Services, in consultation with the California Environmental Protection Agency, to develop a sustainability program for the state's procurement of shipping and transportation services for freight, small package delivery, and other forms of cargo.

Last Action: Held in Assembly Appropriations Committee

**AB 2675 (Lowenthal) State agency: public contracts.**

Requires state agencies that purchase products specified in the State Agency Buy Recycled Campaign to increase the threshold of recycled purchases from 50% to 75% by 2020 for some product categories.

Last Action: Chapter 617, Statutes of 2014

## **STATE PROPERTY**

### **AB 338 (Chavez) State property: surplus.**

Authorizes the Director of the Department of Parks and Recreation, with the approval of the Director of the Department of General Services, to enter into a mutually beneficial agreement with the City of Carlsbad in San Diego County, for the exchange of specified parcels of real property under certain conditions.

Last Action: Held in Assembly Accountability and Administrative Review Committee

### **AB 503 (Wieckowski) State surplus property: disposition: Agnews Developmental Center.**

Authorizes the Department of General Services (DGS) to transfer surplus state property to a local agency at a price that is less than fair market value if the property will be used solely for public school purposes. Authorizes DGS to negotiate with the Santa Clara Unified School District and the City of San Jose to transfer title of the former Agnews Developmental Center for public school purposes, at less than fair market value.

Last Action: Held in Senate Appropriations Committee

### **AB 627 (Gorell) State government.**

Requires a state agency, department, or commission, if it is evaluating the construction of a new building or facility, or the transfer or renewal of a lease for a building or facility, to consider, as a top priority in making that decision, whether a net-zero energy consumption building or facility can be constructed or occupied, as specified.

Last Action: Held in Assembly Accountability and Administrative Review Committee

### **AB 826 (Jones-Sawyer) State property: surplus.**

Authorizes the Department of General Services to dispose of eight surplus state properties, as specified.

Last Action: Chapter 505, Statutes of 2013

### **AB 1421 (Accountability and Administrative Review Committee) Surplus state property: realtors and landlocked properties.**

Provides for the selection of local real estate brokers to sell state surplus property and adds landlocked, remainder, and remnant parcels of land to the types of properties that the Director of the Department of General Services may sell, convey, or exchange at fair market value under specific circumstances.

Last Action: Chapter 276, Statutes 2014

### **AB 1503 (Beth Gaines) Department of General Services.**

Requires the Department of General Services, with consent from the Department of Corrections and Rehabilitation, to lease vacant property on the grounds of California State Prison at Folsom to a specified nonprofit entity for the construction and operation of a peace officers memorial and museum.

Last Action: Vetoed

**AB 1656 (Dickinson) Department of General Services: State buildings.**

Requires the Department of General Services to conduct a long-range planning study by July 1, 2015, of state-controlled and state-owned office buildings in the Sacramento region.

Last Action: Chapter 451, Statutes of 2014

---

**AB 2174 (Accountability and Administrative Review Committee) State property: surplus.**

Authorizes the Director of the Department of General Services to dispose of seven surplus state properties.

Last Action: Chapter 337, Statutes of 2014

**AB 2542 (Bloom) State property: surplus: exchange: Tuna Canyon Property.**

Authorizes the exchange of a specified property between the Department of General Services and the California Department of Transportation.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**AB 2726 (Daly) University of California: real property sales.**

Revises existing law governing how the University of California sells real property.

Last Action: Chapter 361, Statutes of 2014



## **WEIGHTS & MEASURES**

### **AB 1414 (Accountability and Administrative Review Committee) Weights & Measures: annual report.**

Bill was substantively amended and was no longer authored by the Committee.

## **MISCELLANEOUS**

### **AB 378 (Hueso) Resources: Delta research.**

Requires a person conducting research of the Delta, as defined, whose research is funded, in whole or in part, by the state, to take specified actions with regard to the sharing of the primary data, samples, physical collections, and other supporting materials created or gathered in the course of that research.

Last Action: Held in Assembly Accountability and Administrative Review Committee

### **AB 609 (Nestande) State-funded research.**

Requires a grantee who receives research grant funding, in whole or in part, from the California Department of Public Health to provide free public access to any publication resulting from that research within 12 months of publication, as specified.

Last Action: Chapter 789, Statutes of 2014

### **AB 2260 (Alejo) Law enforcement: officers: motor vehicle sales: prohibitions.**

Bans a state or local government law enforcement officer from purchasing or otherwise obtaining a motor vehicle from a towing, transportation, or impound company that does business with the officer's employer.

Last Action: Held in Assembly Appropriations Committee

### **AB 2622 (John A. Pérez) State vehicle fleet purchases: minimum fuel economy standard.**

Requires the Department of General Services to include within the state fleet's fuel economy standard passenger vehicles and light duty trucks that are powered by more than one source.

Last Action: Held in Assembly Accountability and Administrative Review Committee

**ALL SENATE BILLS

**ADMINISTRATIVE PROCEDURE ACT (APA)**

**SB 176 (Galgiani) Administrative procedures.**

Amends the Administrative Procedure Act to increase the requirements for agencies in the rulemaking process. Requires state agencies to make a reasonable effort to consult with interested persons and affected entities at the beginning of the rulemaking process.

Last Action: Held in Assembly Appropriations Committee

**SB 401 (Hueso) Administrative practices.**

Requires any state entity proposing amendments to non-residential model building codes, and when requested for new standards within the model codes, to estimate the cost of compliance and the potential benefits of the new standard as well as disclose the assumptions used to determine the estimates.

Last Action: Chapter 212, Statutes of 2013

**SB 1206 (Evans) State Personnel Board: administrative regulations.**

Makes technical changes to statute governing the State Personnel Board's rulemaking authority by updating references to the Administrative Procedure Act and eliminating obsolete code section references to subject matters that were transferred to the California Department of Human Resources or the Department of Fair Employment and Housing in prior legislation.

Last Action: Chapter 223, Statutes of 2014

**GOVERNMENT ORGANIZATION**

**SB 479 (Block) State government: Secretary of State: duties.**

Transfers responsibility for management of the state's records from the Department of General Services to the Secretary of State, effective July 1, 2014.

Last Action: Held in Assembly Appropriations Committee

**SB 820 (Senate Governmental Organizational Committee) State government.**

Makes necessary and conforming changes in the statutes to properly reflect the assignment and reorganization of the functions of state government as required by the Governor's Reorganization Plan 2.

Last Action: Chapter 353, Statutes of 2013

**SB 1009 (Liu) Public records.**

Allows the Secretary of State to appraise and manage governors' records when they are transferred to the State Archives.

Last Action: Chapter 220, Statutes of 2014

## **OVERSIGHT**

**SB 425 (DeSaulnier) Public works: the Public Works Peer Review Act of 2013.**

Allows a public agency that is principally tasked with administering, planning, developing, and operating a public works project to establish a peer review group, as defined, and requires the administering agency, if a peer review group is established, to draft a charter, published on the agency's Internet Web site, related to the duties of the peer review group.

Last Action: Chapter 252, Statutes of 2013

**SB 486 (DeSaulnier) Department of Transportation: performance measurement benchmarks.**

Requires the California Department of Transportation (Caltrans) and the California State Transportation Agency to identify Caltrans' performance measurement benchmarks and report at least quarterly on performance.

Last Action: Held on Assembly Floor

**SB 801 (Roth) Department of Finance: reports: crimes.**

Directs the Department of Finance (DOF) to annually require each department head, or designee, responsible for auditing the accounts of a state entity, as specified, to certify under penalty of perjury that the budgeting and accounting information provided to the DOF reconciles to the year-end finance reports submitted to the State Controller's Office. Subjects an individual who willfully makes and subscribes a certification that he/she knows to be false to the penalties for perjury established in the Penal Code.

Last Action: Chapter 281, Statutes of 2013

**SB 969 (DeSaulnier) Public works.**

Requires an agency administering a transportation megaproject, as defined, to develop a comprehensive risk management plan and establish a peer review group to review the project's plans and finances.

Last Action: Vetoed

**SB 1074 (Knight) State government: state funds.**

Makes it a misdemeanor, punishable by up to one year in a county jail, or a \$2,500 fine, or both, for a state employee to knowingly transfer or use state money outside of the State Treasury System without authorization from statute or the Department of Finance.

Last Action: Chapter 221, Statutes of 2014

**SB 1337 (DeSaulnier) Reports.**

Adds a new provision to the Government Code that requires written reports submitted to the Legislature or executive body, by any state agency or department, to include a signed statement by the head of that agency or department declaring that the factual contents of the report are true, accurate and complete to the best of his/her knowledge.

Last Action: Vetoed

## **PUBLIC CONTRACTS**

**SB 124 (Corbett) Public contracts: bid preferences: clean energy.**

Bill was substantively amended to a new subject area outside of committee's jurisdiction.

**SB 297 (Roth) Public contracts: disabled veterans.**

Increases the annual statewide participation goal for disabled veteran business enterprises, applicable to certain state contracts, from 3% to 5%.

Last Action: Held in Jobs, Economic Development, and the Economy Committee

**SB 328 (Knight) Counties: public works contracts.**

Authorizes a county, until January 1, 2018, with the board of supervisors' approval, to use construction manager at-risk construction contracts to erect, construct, alter, repair, or improve any building owned or leased by the county.

Last Action: Chapter 517, Statutes of 2013

**SB 399 (Wright) California Prompt Payment Act.**

Adds a contractor performing emergency work or remedial measures related to the accidental or unplanned release of toxic substances to the list of entities entitled to the late payment penalty of 10% above the United States Prime Rate.

Last Action: Vetoed

**SB 502 (Block) University of California: bidding requirements.**

Increases the threshold in which the University of California may use a streamlined bidding process for construction projects from \$100,000 to \$640,000, and sets a qualifications process for prospective bidders on projects in which costs exceed \$300,000.

Last Action: Chapter 364, Statutes of 2014

**SB 975 (Leiu) Personal services contracts: legal compliance.**

Requires every bidder on a state personal services contract to complete, under penalty of perjury, a standardized questionnaire as to whether the bidder has ever violated state tax law or laws and regulations related to health and safety, labor and employment, or licensing of the contractor's employees, worksite, bid and contract, and if so, to explain the circumstances prior to awarding a contract.

Last Action: Vetoed

## **STATE PROPERTY**

### **SB 944 (Torres) Surplus state property.**

Prohibits the Lanterman Developmental Center, which has been declared surplus state property, from being pre-zoned, zoned, or re-zoned unless the change is requested or approved by the Department of General Services.

Last Action: Chapter 515, Statutes of 2014

## **WEIGHTS & MEASURES**

### **SJR 29 (Lieu) Natural gas vehicle fuel standards.**

Urges any official of the State of California involved with the National Conference on Weights and Measures and acting in his or her official capacity to support the natural gas vehicle fuel standards recommended by the Natural Gas Steering Committee of the National Conference and Weights and Measures.

Last Action: Held in Assembly Accountability and Administrative Review Committee

## **MISCELLANEOUS**

### **SB 1265 (Hueso) State vehicle fleet purchases: minimum fuel economy standard.**

Subjects vehicles that are powered by more than one source, including nonplug-in hybrid electric vehicles, to the state fleet's minimum fuel economy standards.

Last Action: Chapter 398, Statutes of 2014
