THE 10 COMMANDMENTS OF CROSS EXAMINATION

The late Irving Younger promulgated the "Ten Commandments of Cross-Examination." These commandments have all been violated almost as many times as the Commandments announced by Moses. Nonetheless, they provide a good set of guidelines:

- BE BRIEF. Make only three points about a witness' credibility.
- II. SHORT QUESTIONS, PLAIN WORDS. Do not use legalese or technical terms.
- III. NEVER ASK ANYTHING
 BUT LEADING QUESTIONS.
 Who, what, where, when, why,
 how, explain and describe
 questions SHOULD NOT be
 asked on cross.
- IV. ASK ONLY QUESTIONS TO WHICH YOU ALREADY KNOW THE ANSWER. Ask questions that you know you can impeach the witness with if the witness does not say yes as a response.
- V. LISTEN TO THE ANSWER.

 Make sure you get the answer
 you are looking for.
- VI. DO NOT ARGUE WITH THE WITNESS.
- VII. DO NOT PERMIT A
 WITNESS TO SIMPLY
 REPEAT HIS DIRECT
 TESTIMONY.
- VIII. DO NOT LET THE WITNESS EXPLAIN. Use your witness control techniques to prevent the witness from volunteering information.
- IX. AVOID ASKING ONE QUESTION TOO MANY.
- X. SAVE IT FOR SUMMATION.

Closing Arguments Tips

The closing argument is an organized reminder for the jury, a detailed explanation and a passionate argument to persuade the fact finder.

A good closing should serve as a:

- reminder of all the favorable information that the jury heard throughout trial
- detailed explanation of the evidence in clear, simple terms of your case theory and theme
- passionate argument to the jury about how they should view the evidence, what they should do with it and how they should vote in deliberations

Key Reminders

- 1. "Re-hook" keep the jury interested
- 2. Re-visit your theme/theory from your opening statement
- 3. All witness examinations were constructed with closing in mind (*ABC*: Always Be Closing).
- 4. Use exhibits and demonstratives to tell your story
- 5. Argue about what happened at trial "remember when . . ."
 "today, he said . . ."
- 6. Emphasize your case strengths and explain inferences
- 7. Deal frankly with your case weaknesses
- 8. Force your opponent to answer to the weaknesses in their case
- 9. You are limited to the record.

 Never refer to excluded

 evidence
- 10. Your personal beliefs and opinions are forbidden
