**Greenaction for Health** and Environmental Justice, I write to inquire if the California **Department of Public Health's Radiological** Health Branch ("CDPH") plans to respond to **Greenaction's petition** under 17 C.C.R. § 30205 to revoke Tetra Tech EC. Inc.'s ("Tetra Tech") **California Radiological** Materials License No. 7909-01. The Petition was submitted to you on July 26, 2018 via email. The original Petition and its 25 suppotiing exhibits are still available online. We have not received a reply from CDPH, nor are we aware of any action by **CDPH** on the Petition. Meanwhile, the true scope and impact of Tetra Tech's fraud, committed while operating under its **Radiological Health** Branch license. continues to be exposed...

### What's New in the Past Year

# Environmental Law & Justice Clinic Hunter's Point Naval Shipyard Documents

This Hunters Point Naval Shipyard archive hosts various Environmental Law and Justice Clinic filings and documents generated in advocating for the cleanup of radiological contamination at the Hunters Point Naval Shipyard. The Clinic, on behalf of Greenaction for Health and Environmental Justice, began investigating the Navy's cleanup at the Shipyard in 2017 to ensure the Navy's cleanup of the site protects human health and the environment, as required under federal Superfund law.

The Clinic worked with whistleblowers to make public the whistleblowers' allegations of fraud in the Shipyard cleanup. We included detailed accounts of fraud in petitions to the Nuclear Regulatory Commission and the California Department of Public Health, asking those agencies to revoke the licenses of a contractor implicated in the fraudulent cleanup. Select documents related to the federal (NRC) and state (CDPH) petitions are included below.

The Clinic has also submitted comments to the Navy and the U.S. Environmental Protection Agency related the Navy's cleanup. These comments focus on issues including: (1) the Navy's failure to acknowledge the impact of the fraud; and (2) the inadequacy of Navy's plans to protect the public from exposure to radioactive waste at the Shipyard. Select documents related to the Clinic's comments are included in this collection.

This collection has already seen 227 downloads!

Digital Commons also gives us the capability to link to outside articles, video and audio presentations that are hosted on other sites, and to embed video clips that are hosted on sites such as YouTube and Vimeo. Authors with a current email address receive monthly reports of their article downloads directly from bepress.

"The Survey highlights some of the Ninth Circuit's most challenging and notable cases. This year's issue features Perez v. Roseville, 882 F.3d 843 (9th Cir. 2019), superseded by 926 F.3d 511 (9th Cir. 2019), and Williams v. Gaye, 895 F.3d 1106 (9th Cir. 2018). In Perez, the court considered the complex issue of whether the defendants, police officials who had investigated a complaint against a fellow officer that led to the officer's termination, were entitled to qualified immunity from 42 U.S.C. § 1983 claims. Williams, by contrast, was a copyright infringement action arising out of the allegation that Pharrell Williams and Robin **Thicke's "Blurred Lines"** had copied from Marvin Gaye's "Got to Give It Up." 
## **Federal Government Documents**
