## CHANGES/CORRECTIONS FALL 2011 COURSE SCHEDULE

Room numbers are not included in the printed schedule and room information on the website is not final. Room numbers will be posted by the Law Registrar's Office on the second & third floors at the start of the term. After that room changes will be posted on the Room Change Bulletin Board on the third floor west corridor.

### NEW CHANGES

**LAW 732 Appellate Advocacy §LSN2** has been  **canceled**  from the fall 2011 course schedule.

**LAW 896J Externship: Capital Post-Conviction Defense** has been  **canceled**  from the fall course schedule. It is planned that it will be offered in the spring term.

### PREVIOUS CHANGES

**LAW 837A Family Law §LSN** will satisfy the Upper Division Writing requirement for JD students admitted in Fall 2010 or later. The code in the column on the left of the line schedule in the Orientation Edition has been  **changed**  from 'L' to  **'W'** .

**Changes above this are to the Orientation Edition**

**LLM 396 Graduate Legal Writing & Research §LS1** will be taught in the fall term by  **Margaret Greene** .

**LAW 869 California Legal Research §LS1** and  **§LS2**  have been  **canceled**  from the fall course schedule. It is anticipated that this course will be offered in the spring 2012 term.

**LAW 899F Advanced Trial Advocacy §LS1** will meet on  **Thursday**  nights at  **6:30-9:10 PM** , not at 5:30-9:10 as originally scheduled.

**LAW 863C Legal Methods §LSN** has been  **moved**  from Tuesday nights to  **Wednesday**  nights at 6:30-8:10 PM for the fall term.

**LAW 883T Advanced Real Estate Transactions Seminar §LSN** has been **changed** to **LAW 883T Real Estate Practice – Transactions §LSN**. This is a name change only and does not alter the scheduling or content of the course.

**LAW 883 Externship: Real Estate §LS1** no longer requires LAW 715C Real Estate Transactions as a prerequisite to enroll in the course. Students will still have to have completed the 6-unit Property I & II or the 4-unit Property course.

**LAW 899B Trial Advocacy §LS4** has been **canceled** from the fall 2011 course schedule.

**LAW 899F Advanced Trial Advocacy §LS2** has been **added** to the fall course schedule on **Wednesdays at 9:00–11:40 AM**. This section will be taught by **Brian Soriano**.

**LAW 715 Property §LSN** will be taught by **Kimberly Stanley** instead of Marci Kelly. The dates of the 5 extra classes for this section have been **changed** to **Fridays, August 26, September 2 & 16, October 21 and November 11 at 6:30–9:10 PM**.

**LAW 807 Wills & Trusts §LSN** will be taught by **Marci Kelly** instead of Anthony Pagano. The dates of the 5 extra classes for this section have been **changed** to **Fridays, September 9, 16, & 30 October 21 & 28 at 6:30–9:10 PM**.

**LAW 899I Competition: Environmental Law Moot Court §LSN** has been **moved** from Mondays to **Tuesdays at 6:30–9:10 PM**.

It has come to our attention that some students may have received fall course information prior to publication of the course schedule which used course names that had been changed by the time the schedule was published. Please note the following **California Bar Subject** courses which are in the fall schedule.

**LAW 720G Privacy, Defamation, & Other Relational Torts** – this course replaced LAW 720D Advanced Torts.

**LAW 715C Real Estate Transactions** – previously referred to as “Advanced Property”.

**LAW 899F Advanced Trial Advocacy §LSN** has **replaced** LAW 899C Competition – Mock Trial in the fall schedule. It will still be taught by **Bernard Segal** and **Brian Soriano** on **Thursdays at 5:30–9:10 PM**. The new course description and scheduling note are below.

**Course Description:**

### **LAW 899F Advanced Trial Advocacy** (3 units)

This course, formerly offered as "Competition: Mock Trial" or "Basic Mock Trial" is designed to give students an opportunity for additional experience beyond the one final trial in Trial Advocacy. The Litigation Center is premised on the notion that trial skills are developed and honed through experience. In Advanced Trial Advocacy every student will participate as counsel in at least three full trials, as well as in several additional trials as witnesses and jurors. This course will be offered only in the fall semester. Students in this class may also be selected to represent the law school in mock trial competitions during the fall semester. This course is a required course for the JD Litigation Certificate. This course is graded on a Credit/No Credit basis. Prerequisites: Evidence and Trial Advocacy.

#### **Scheduling note:**

**Advanced Trial Advocacy** (formerly "Competition- Mock Trial" or "Basic Mock Trial") - This course will meet on campus for approximately 6 formal classroom sessions. Students conduct trials for the remaining 8 sessions of the course, which are usually held at the Hall of Justice, 850 Bryant St., San Francisco. For these sessions, students must be present at the Hall of Justice at 5:15 pm, trials begin shortly thereafter and must conclude by 9:45 pm. Inquiries regarding this course should be directed to Professors Bernard Segal, or Wes Porter.

**LAW 899G Competition: Mock Trial §LS1** has been **added** to the fall course schedule. This course will be taught by **Wes Porter**. This course has no scheduled class meetings, but **mandatory mock trial team practice sessions** will be scheduled later as described in the scheduling note below.

#### **Course description:**

### **LAW 899G Competition: Mock Trial** (2 units)

This course is open only to students who have been selected by the instructor to represent the law school in an inter-school mock trial competition. The number of mock trial competitions, and corresponding student competitors, varies from year to year. Selection to compete in mock trial competitions will be based upon an application and tryout open to all upper division students who have completed Evidence and have completed or are currently enrolled in Trial Advocacy. Consent of the instructor is required for registration in this course. Prerequisite: Evidence, Co-requisite: Trial Advocacy.

#### **Scheduling note:**

**Competition: Mock Trial** – Students enrolling in this course should be aware that, although there is no scheduled time, **mandatory** mock trial team practice sessions are scheduled for as many as 7 weeks leading up to the competition. In recent semesters, mock trial teams have met up to

3 times per week, including in the evenings and on one weekend day. The mock trial competitions require weeks of preparation, but are typically completed by November 7th for the fall term or April 7th for the spring. Students may compete in more than one term if they are selected again for competition teams.

**LAW 899B Trial Advocacy §LS3** has been **moved** from Mondays at 9:00-11:40 AM to **Tuesdays** at **1:15-3:55 PM**.

**LAW 898A Criminal Litigation §LSN** has been **added** to the fall 2011 course schedule on **Thursday** nights at **6:30-9:10 PM**. This course will be taught by **Teresa Caffese**.
