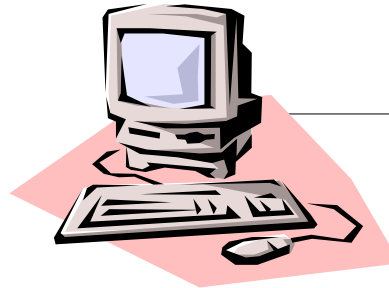

John Vietor, a representative from Loislaw, was on campus on February 22nd to show students how Loislaw can help them to conduct efficient legal research. The presentation highlighted Loislaw's collection of federal and state primary law - from cases and codes, to court rules and forms - as well as the service's topical collections on Probate, Criminal law and other subjects. In addition to discussing the utility of Loislaw and the breadth of its collection, John also spoke about how Loislaw plans to expand in the future and its place in the world of electronic legal databases. ## GARY'S CORNER

**The Emperor of Ocean Park** by Stephan Carter. Alfred Knopf, 2002. This book will be found in our Legal Fiction collection on the basement level.

Talcott Garland has got problems. His father, conservative giant, Oliver Garland, the emperor of Ocean Park, has just died of a heart attack. His sister, Mariah thinks that it is murder. Strange things begin happening. People start coming to Talcott about the "arrangements" which only he is supposed to know about, only he doesn't. His wife, Kimmer, is obsessed with getting a prominent judgeship and her mysterious and suspicious absences have become long and frequent. Talcott is being followed by more than one person, while people close to the judge start ending up dead. As he is dragged deeper into the mystery that is the judge's life and vendettas, his professorship at a prominent law school becomes precarious.

In addition to being a mystery, this is a sociological slice of life of upper-middle class African-Americans, or as the Garland family refers to themselves, "The Darker Nation." The action takes us from Washington D.C. to the college
