## THE ANGLO-AMERICAN LEGAL TRADITION

"The Quinn Law Library at the University of Houston Law Center is proud to announce the inauguration of the extraordinary new website, the [Anglo-American Legal Tradition](#) (AALT). The AALT offers the free, non-commercial, public display and use of the images of the main categories of court records over almost four centuries (c.1272 - 1650); at this point, some 450,000 images have been acquired. In order to facilitate use of these ancient documents the site supplies guides to paleography and overviews of English legal history, as well as links to other websites of interest to legal historians. The AALT will continue to add images from the National Archives, as well as collections of historical documents from other court systems in the Anglo-American legal world."

## “WHY DO YOU NEED SPACE FOR ALL THOSE BOOKS WHEN EVERYTHING IS ONLINE?”

Because the ABA says so.

ABA requirements for accreditation include Standard 606:

- The law library shall provide a core collection of essential materials accessible in the law library.

Interpretation 606-1:

- All materials necessary to the programs of the law school shall be complete and current and in sufficient quantity or with sufficient access to meet faculty and student needs. The library shall ensure continuing access to all information necessary to the law school's program.

Interpretation 606-5:

- A law library core collection shall include the following: federal court decisions, highest state court decisions for all states, all federal codes and session laws, an annotated code for each state, all current published treaties and international agreements, all current published regulations, administrative decisions, Congressional materials, secondary works (treatises), and locator tools such as indexes and citators.

There are reasons the ABA says so. These reasons concern the general lack of reliability, accuracy, editorial enhancement, and thoroughness of what might be found, free of charge, online. Besides, putting material worth reading on the internet costs time and money. Books and subscription databases are often worth what we pay for them.
