**United States Circuit Judge of the
United States Court of Appeals for the Ninth Circuit**

Judge Morgan Christen was appointed to serve on the United States Court of Appeals for the Ninth Circuit in January of 2012. She currently serves on the Ninth Circuit's Judicial Council, Ninth Circuit's Executive Committee, the Circuit Conference Executive Committee, the Courts and Communities Committee, the Pacific Islands Committee, and chairs the Cameras in the Courtroom Committee. In October 2019, she began a three-year term on the Judicial Conference Committee on Federal-State Jurisdiction. Judge Christen chaired the Rhodes Scholarship Selection Committee for District 14 in 2017, 2018, and 2019.

Prior to her appointment as a Ninth Circuit Judge, Judge Christen served as a justice on the Alaska Supreme Court. Judge Christen was born and raised in Washington, and

attended college in England, Switzerland, and the People's Republic of China. She earned a B.A. degree from the University of Washington in International Studies and a J.D. degree from Golden Gate University School of Law. After law school, Judge Christen clerked for Judge Brian Shortell, and then joined Preston Gates & Ellis where she practiced civil litigation. Judge Christen was appointed to the Alaska Superior Court in 2001 and served as Presiding Judge of the Third Judicial District from 2005-2009.

Judge Christen was awarded the Light of Hope Award for work on behalf of Alaska's children and she and her husband, Jim Torgerson, were named Philanthropists of the Year in 2004. Judge Christen is a past recipient of the Alaska Supreme Court's Community Outreach Award, the Chamber of Commerce Athena Award, and a YWCA Woman of Achievement. Judge Christen and her husband live in Anchorage. They have one daughter.

**Presiding Judge, Superior Court of California,
County of Mendocino**

Joining the bench in 2011, Judge Ann Moorman currently serves as presiding judge for the Superior Court of Mendocino County. In addition to her duties as presiding judge, she oversees Mendocino's adult Behavioral Health Court and assists in dependency, delinquency, and criminal matters. She has handled felonies and associated misdemeanors from arraignment through trial and sentencing. Judge Moorman also sits on the Judicial Council, following her appointment by the Chief Justice, and serves as Vice Chair of the Judicial Branch Budget Committee.

In 2013, Judge Moorman spearheaded the creation of the Behavioral Health Court by drafting the grant application and developing the policies and practices of the court. This specialty court is a type of collaborative justice court, also

known as problem-solving courts, which combine judicial supervision with rehabilitation services that focus on reducing recidivism and improving offender outcomes.

Off the bench, Judge Moorman has served as president of both the California Attorneys for Criminal Justice and the Legal Services Corporation of Mendocino and Lake Counties. She is also fellow in the American College of Trial Lawyers.

Prior to joining the bench, Judge Moorman worked in private practice in civil and criminal matters, later specializing in complex white-collar litigation.
