## A COMPREHENSIVE CURRICULUM



### GOLDEN GATE LAW OFFERS A BROAD CURRICULUM THAT STRESSES THE FUNDAMENTALS OF LEGAL THEORY AND PRACTICE AND THE HIGHEST ETHICAL AND PROFESSIONAL STANDARDS.

At Golden Gate Law, students simultaneously master high-level legal writing and analysis and the day-to-day essentials of legal practice. After the first year they may explore specific areas of law in depth by obtaining optional Certificates of Specialization and examining legal issues from multiple perspectives through the Law School's interdisciplinary centers and symposia.

#### Practical Legal Training

Golden Gate Law houses award-winning clinics and offers a wide array of field-placement externships aimed at providing hands-on experience in law offices, government agencies, judges' chambers and non-profit advocacy organizations.

#### Joint Degree Programs

JD/MBA: Depending upon their pre-law school course work, students may earn an MBA from Golden Gate University in two or fewer semesters beyond the completion of the JD program. This combined program allows students to obtain both degrees in less time and at lower cost than if they were to pursue them separately.

JD/PhD in Clinical Psychology: Students earn a JD from Golden Gate Law and a PhD in Clinical Psychology from the Pacific Graduate School of Psychology at Palo Alto University.

#### Study Abroad

While enrolled at Golden Gate Law, students may study comparative and international law in the summer

study abroad program in Paris at the University of Paris X-Nanterre, or in San Sebastian, Spain at the University of the Basque Country.

#### Graduate Law Programs

Golden Gate Law offers several highly respected graduate law programs leading to the Master of Laws (LLM) and Doctor of Juridical Science (SJD) degrees. These programs bring practicing attorneys, government officials, and international scholars onto campus, where they study with and provide valuable professional contacts to JD students.

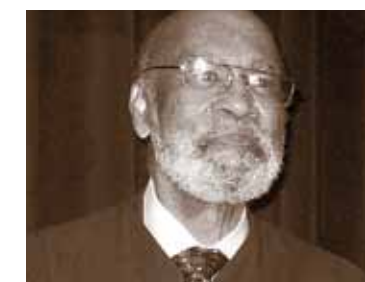
#### Part-Time Evening Program

Golden Gate Law's part-time evening program makes it feasible for students to obtain a JD degree in four years while working full-time, caring for

children or other family members, or simply taking fewer units per semester to lower the annual cost of attendance. Classes are taught by full-time faculty, and essential training and programming opportunities are carefully planned to accommodate the needs of evening students.

#### 1L Electives

Designed to introduce first-year students to the basics of legal practice through simulations and real-world problems, 1L electives give students the opportunity to choose courses that match their interests as early as the second semester of law school. Recent offerings include Ethics in Criminal Law, Hot Topics in Business Bankruptcy Law, White Collar Crime in Practice, and Asylum Law.

**G**olden Gate Law offers outstanding hands-on training opportunities through an extensive array of field placement externships and through our on-site legal clinics.

#### Environmental Law and Justice Clinic

In 1994 Golden Gate Law became one of the nation's first law schools to establish an on-site environmental justice clinic to address the needs of low-income communities disproportionately impacted by industrial pollution.

The Environmental Law and Justice Clinic (ELJC), a core component of Golden Gate Law's Environmental Law Program, received the 2006 Clinical Legal Education Association Award for Excellence in a Public Interest Case or Project for its success in representing clients working to shut down an aging and polluting power plant in Southeast San Francisco. Recent clinic victories have included successfully arguing that a proposed sewage composting facility in Southern California needed further review and compelling both a steel foundry in Berkeley, CA and a pulp mill near Eureka, CA to reduce toxic emissions. In 2009, the United States Environmental Protection Agency Region 9 presented the ELJC with an Award for Outstanding Achievement in recognition of its exceptional work and commitment to protecting the environment.

#### Women's Employment Rights Clinic

Through the Women's Employment Rights Clinic, founded in 1993, students at Golden Gate Law represent low-income, often immigrant workers who might otherwise lack legal counsel in disputes with employers. The clinic's successes have included settling a gender discrimination case on behalf of six female electricians who asserted they were targeted for layoffs on the basis of gender.

#### Pro Bono Tax Clinic

The Pro Bono Tax Clinic provides assistance to low-income individuals in certain tax disputes before the California Board of Equalization.

## COMPETITIONS & ADVOCACY

### THE HONORS LAWYERING PROGRAM TAKES A UNIQUE APPROACH TO LEGAL EDUCATION, INTEGRATING THE THEORY, SKILLS, AND VALUES LEARNED IN THE CLASSROOM WITH ACTUAL WORK IN THE LEGAL COMMUNITY — A MODERN VERSION OF THE TRADITIONAL APPRENTICESHIP.

HLP students attend the regular first-year curriculum, participate in an intensive skills-focused summer session, and work at a full-time fall apprenticeship. In the spring, students return to full-time classes with a new appreciation for the application of law to practice. During their third year, students complete a second apprenticeship and have the option to enroll in additional, practice-based courses.

HLP courses meet in small sections that integrate lawyering skills training with the substantive law curriculum. By the third week, students begin representing real clients under the guidance and

supervision of the professors, who are themselves practicing attorneys. Students may apprentice in private law firms, companies, courts, government agencies, and public interest organizations.

A dedicated HLP career adviser assists HLP students with securing apprenticeships and students are free to explore opportunities in any area of practice. At the time they begin their first apprenticeship, HLP students are well-trained and prepared to provide meaningful assistance to employers. They are also qualified to represent clients through the State Bar of California's Practical Training of Law Students Program.

Admission into HLP is very competitive and graduates of the program are highly regarded by legal employers. HLP students are a tight-knit group and the summer program is designed to foster the development of personal and professional relationships that will extend far beyond graduation from law school.

In and out of the classroom, Golden Gate students are grounded in the basic foundations of trial advocacy and have many opportunities to hone their skills. Through Golden Gate Law's Appellate Advocacy course, every JD student is required to participate in a moot court exercise before graduation.

Appellate Advocacy is aimed at helping students develop strong skills in oral and written advocacy, key aspects of any lawyer's training. By the end of the course students are able to write clearly and concisely, argue persuasively on behalf of a client, analyze complex legal issues, present an oral argument to an appellate-level court and comply with relevant court rules and policies. Top students compete in our annual Appellate Advocacy Competition.

Upper-year students may elect to take Mock Trial, where they try a "mock"

case three times during the semester and participate in their classmates' cases as witnesses. The Mock Trial course is held in Golden Gate Law's Moot Courtroom and at the Hall of Justice in San Francisco's Civic Center.

Golden Gate Law students may be selected to compete in prestigious regional, state, national and international competitions, including the Jessup International Law Moot Court Competition and the National Environmental Law Moot Court Competition. Golden Gate Law placed second in the 2008 State Bar of California Environmental Negotiations Competition and recently won the San Francisco Trial Lawyers Association Competition. Students are coached by renowned professors such as Bernard Segal, Director of the Litigation Program.

## LIBRARY & PUBLICATIONS



### GOLDEN GATE UNIVERSITY'S LAW LIBRARY HOUSES THE LARGEST LEGAL COLLECTION IN SAN FRANCISCO'S FINANCIAL DISTRICT, WITH MORE THAN 373,000 VOLUMES, MICROFORMS AND ELECTRONIC RESOURCES.

The Law Library has recently undergone a major expansion and renovation and features a comfortable new reading room, numerous study carrels, wiring for laptop computers and wireless access to Golden Gate's online network.

Holdings include a comprehensive series of case law, statutes, digests, encyclopedias, periodicals and treatises dealing with American law; a robust tax collection; microforms and government document collections; extensive international law collections, particularly in Pacific Rim countries, the European Union and the United Nations; and an expansive body of work in environmental law.

#### Research Journals

Golden Gate Law publishes three scholarly research journals staffed by students selected on the basis of their academic standing and outstanding writing ability.

*The Golden Gate University Law Review* is published three times a year and includes the *Ninth Circuit Survey*, the only law review journal dedicated solely to addressing cases decided by the Ninth Circuit Court of Appeals.

*The Golden Gate University Environmental Law Journal* is published twice during the academic year. The winter Pacific Region edition addresses

environmental legal issues pertaining to Pacific Rim countries. The summer edition focuses on the topic of our Annual Environmental Law Symposium.

*The Annual Survey of International and Comparative Law* is published once a year. Recent articles have included "The Modern Concept of Secularism and Islamic Jurisprudence: A Comparative Analysis" and "Universal Human Rights: A Generational History."

## CENTERS, SYMPOSIA & SPECIAL PROGRAMS



At Golden Gate Law we provide an interdisciplinary focus on legal learning in which students, faculty and practitioners analyze legal problems from a variety of perspectives in search of practical solutions.

Our Intellectual Property Law Center brings together noted attorneys and scholars to promote a nuanced understanding of cutting-edge issues in intellectual property law and policy. The Center also sponsors an annual Intellectual

Property Law Conference and the Distinguished Intellectual Property Law Speaker Series.

The Sompong Sucharitkul Center for Advanced International Legal Studies advances scholarship and

dialogue on comparative and international law, as does the Annual Fulbright Symposium on Current International Legal Problems.

Our Appellate Advocacy Institute sponsors Moot Courts for Practicing Attorneys where students observe lawyers rehearsing their oral arguments. The Annual Environmental Law Symposium addresses topics such as renewable energy and environmental justice.

Golden Gate Law also hosts the Jesse Carter Distinguished Lecture Series. Named for Jesse W. Carter (Class of 1913), former associate justice of the California Supreme Court, the lectures explore current issues of jurisprudence and public policy. In 2009 we proudly inaugurated the Chief Justice Ronald M. George Lecture, the first in a series of annual addresses by state Supreme Court chief justices.

### LAW & LEADERSHIP PROGRAM

The Law & Leadership Program is an innovative approach to developing leadership skills among law students and reflects Golden Gate Law's particular commitment to training students to exhibit and value professionalism. Following a competitive application process, 12 second and third-year students are invited to participate in a year-long seminar led by faculty and senior staff mentors. Workshop-style classes use role plays and other interactive exercises to practice professional skills and behavior. Students assess their own leadership styles, examine the connection between building satisfying professional relationships and effective leadership, and consider the value of public service as a path to leadership. The Law & Leadership Program is one of only a handful of law school leadership programs in the country.

##### Certificate of Specialization in Intellectual Property (IP) Law

Students must complete required coursework, which can include a clinical experience, supervised research project, or participation

in one of several moot court competitions. Students may also join our active Intellectual Property Law Association which offers many opportunities for networking, travel to national conferences and leadership development.

##### The Intellectual Property Law Center

The Center brings together students, faculty, lawyers, judges and IP law scholars to explore developments in the fast-changing world of IP law and policy. The Center is led by faculty with extensive IP law experience, assisted by a distinguished advisory board comprised of prominent attorneys from Bay Area law firms,

in-house counsel, federal judges and lawyers at the U.S. Patent and Trademark Office. With its proximity to Silicon Valley and close ties to California's entertainment centers, the IP Law Center offers excellent opportunities for research and training.

The Center sponsors a prestigious **Annual Intellectual Property Law Conference**, as well as the **Distinguished Intellectual Property Law Speaker Series** (which in 2009 included William Patry, Senior Copyright Counsel, Google, Inc.), an IP Mentorship Program, an IP section in the Law Library and an alumni network listserv to keep current and former students apprised of events and job opportunities.

Golden Gate Law's Intellectual Property Law Program features over two dozen IP-focused courses. Students gain broad theoretical and practical understanding

of this rapidly growing field and can explore its many niche areas, including copyright, entertainment and sports law; internet and software law; patent and biotechnology law; and trademark and unfair competition law. Students also develop expertise in closely related and often overlapping fields of study, such as international law, particularly with respect to cyberlaw.

Students can gain direct experience in their particular area of interest working with Golden Gate Law's on-site Environmental Law and Justice Clinic and Women's Employment Rights Clinic or off-site field placement externships.

Students attend the Bay Area's Public Interest/Public Sector Legal Careers Day, an annual job fair that draws over 100 public interest and government employers to San Francisco.

##### Funding Public Interest Work

The Public Interest Law Scholars Program at Golden Gate grants several \$5,000 annual scholarships to entering students with extensive public service experience. During the summer, Golden Gate Law is among the few law schools to pay the employer's portion of a work-study award for students working

#### Certificate of Specialization in Taxation Law

Golden Gate Law's Taxation Law Program is one of the preeminent tax law programs in the western United States. Studying under experienced faculty, students gain a solid foundation in the basics of federal, state and local taxation as well as real estate, partnership, corporate and international tax law. Students may choose to branch out into areas of particular interest, including business taxation, estate planning or employee benefits.

Students must complete a set number of core courses and electives and many go on to earn an advanced degree, applying up to 12 units of related JD coursework to an LLM in Taxation Law. The School of Law offers tax-related programming and job fairs throughout the year,

including several hosted by the Young Tax Lawyers Association. Students may also participate in the CAPITAL Group (Corporate Asset-Management Property Investment and Tax Association) law student organization.

They are responsible for ascertaining the issues presented on appeal, conducting the necessary research and preparing briefs for the board's consideration. Students learn tax and administrative law and client counseling techniques while providing a valuable service to underserved members of society. Students work under the direct supervision of an attorney from the Board of

Equalization and attend a classroom training meeting every two weeks.

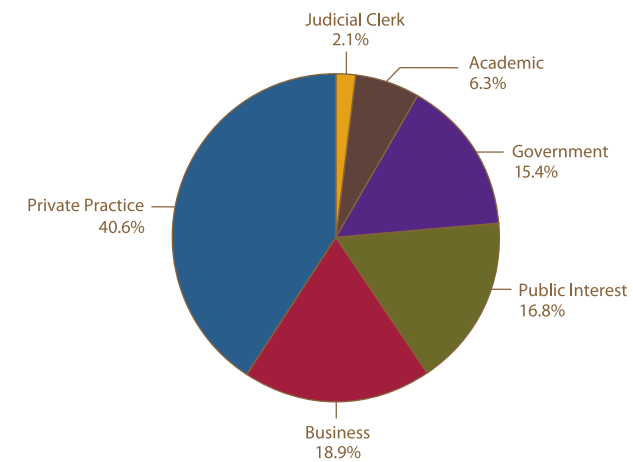

## HOW TO APPLY



Golden Gate Law strives to admit students who are seeking a rigorous legal education that provides a holistic, practical approach to legal learning. The application process is designed to identify applicants who have the ability to succeed in the classroom and contribute to the legal community on and off campus.

The Admissions Committee evaluates applicants to determine whether objective indicators such as LSAT scores and post-secondary transcripts demonstrate the preparedness to meet the challenges of legal study. The committee also looks for evidence of strong writing ability, leadership skills, professionalism and the motivation to attend Golden Gate Law. Personal statements, letters of recommendation and resumes are used to further develop the Admissions Committee's understanding of each applicant's potential for success. The committee appreciates materials that provide

an honest statement about the applicant's achievements, goals, anticipated challenges and preferred learning environment.

Please note that the Admissions Committee prefers not to consider LSAT scores that are more than three years old and in no circumstances will they consider a score that is more than five years old.

Golden Gate Law does not require a specific course of undergraduate study to apply, but does require that applicants have or will have completed an undergraduate degree at an accredited institution prior to matriculation. An original copy of each entering student's official undergraduate transcript will be required prior to matriculation.

### Transfer & Visiting Applicants

Students seeking to enroll as visiting or transfer students must be currently enrolled at an ABA-accredited law school, in good academic standing and have completed the first year of study. The application must include a current law school transcript, a letter of reference from a law professor and a letter from the Dean or Registrar at the applicant's current institution. ### International Applicants

Students who have completed their undergraduate studies outside the

United States or Canada must have their transcripts evaluated through the LSDAS Credential Assembly Service. A TOEFL score will be required for any student whose course of study was not completed in English. The minimum TOEFL score accepted by Golden Gate Law is 250 on the computer-based test or 600 on the paper-based test. ## SCHOLARSHIPS & FINANCIAL AID



### Entering Student Scholarships

Golden Gate Law awards both full-tuition Dean's Scholarships and partial-tuition Faculty Scholarships to qualified entering students. All entering scholarships are awarded on a three-year basis for full-time students and four-year basis for part-time students. There is no separate application for entering student scholarships as all students are considered for scholarships at the time they are admitted to the JD program. Entering scholarships are typically awarded to students whose application materials demonstrate outstanding achievement in one or more of the following areas: academic record, LSAT scores, writing ability, professional experience, volunteer service, or community leadership. Applicants are strongly encouraged to apply early in order to maximize the chances of obtaining a scholarship.

Golden Gate Law also awards \$5000 scholarships to students whose applications highlight a strong commitment to public service or environmental law. The Public Interest Scholars Program and Environmental Law Scholars Program require supplemental materials detailing the applicant's volunteer and employment history and evidence the applicant's intent to pursue a career in one of these areas of law.

### Continuing Scholarships

Students who are not selected to receive an entering scholarship may be eligible for a merit scholarship after completing the first year of classes. Continuing scholarships are awarded on the basis of academic performance. Additionally, Golden Gate Law offers many donor-funded special scholarships to continuing students who meet the specific award criteria.

### Loans

Golden Gate Law is committed to helping our students make wise borrowing choices. Students attending Golden Gate Law may qualify for a variety of federal and private student loan programs. Our experienced Financial Aid staff are available to work with entering students in order to demystify the process of applying for financial aid and develop a realistic budget for law school.
