MEMORANDUM

May 31, 1977

TO: City editors and assignment editors

Following are texts of citations to recipients of honorary degrees of Doctor of Laws at Golden Gate University's 76th commencement, June 4, 1977, at Masonic Auditorium in San Francisco.

Dianne Feinstein, Member, Board of Supervisors, City & County of San Francisco:

Born in San Francisco and a graduate of Stanford University; a brilliant student and practitioner of public affairs who leaned her craft in two decades of progressively more responsible roles in the governance of her community; at the same time, a successful wife and mother; for the past seven years a Member of the Board of Supervisors of the City and County of San Francisco, and for four of those years the first woman President of that body. Her principled, caring and reasoned leadership has contributed decisively to the sound and humane development of her native city. And by her integrity, judgment, skill and accomplishment she has earned the respect, gratitude and affection of her fellow-citizens and set the highest standards for what public service in our time can and should ideally be.
