
## /// Practice Based



### /// First Year Electives

Designed to introduce first-year students to the basics of legal practice through simulations and real-world problems, first year electives give students the opportunity to select one of more than a dozen courses that match their interests. Recent offerings include Ethics in Criminal Law, Supreme Court Litigation, Asylum Law, and White Collar Crime in Practice.

#### Practice Intensive Courses (PIC)

Practice Intensive Courses infuse substantive law with multiple opportunities for students to cultivate professional skills and values. Through PIC, students utilize various learning and assessment tools, including written assignments and practical simulations, and receive regular written feedback from professors.



#### Field Placements and Externships

All students must complete an experiential learning requirement prior to graduation. GGU Law's robust field placement and externship program offers plenty of opportunities for students to satisfy this requirement through our on-site clinics, simulation courses, or positions in law firms and advocacy organizations across the Bay Area.

#### Graduate Law and Joint Degree Programs

GGU Law's LLM Programs are ranked among the top three in California. The LLM in Taxation is ranked ninth nationally among corporate leaders in tax. GGU Law offers LLM degrees in Environmental Law, Intellectual Property Law, Taxation, and U.S. Legal Studies. We offer both an LLM and an SJD (Doctor of Juridical Science) in International Legal Studies.

Joint degree programs include the JD/LLM in Taxation and the JD/MBA offered in partnership with Golden Gate University's Ageno School of Business.

GGU Law is known for its outstanding litigation program, which has launched the careers of some of the most talented and respected trial attorneys in California. Many litigation courses are interactive, allowing students to practice litigation skills such as interviewing clients, arguing motions, conducting witness examinations, and delivering opening and closing arguments.

GGU Law students participate in regional and national moot court and mock trial competitions, receiving rigorous training by expert faculty and well-known litigators in the area. Students can also participate in several internal competitions, some as early as the first semester of law school.

#### First Summer Trial and Evidence Program (1st STEP)

Specialized coursework and interactive exercises are designed to advance students' litigation and advocacy skills. 1st STEP classes include Evidence, Trial Advocacy, and a unique course called Evidence in the Courtroom. 1st STEP students gain a keen appreciation for effective client representation and successful courtroom advocacy.

## /// Honors Lawyering Program

Each year, a select group of highly qualified students takes part in the Honors Lawyering Program (HLP), which combines seminar-style courses, client interaction, and practical work experience through an intensive summer session followed by a semester-long fall apprenticeship. By the midpoint of their time in law school, HLP students have achieved an unusually high level of knowledge and expertise, a result of the program's innovative approach to experiential learning.

Applicants to the full-time JD program may be considered for HLP as part of the admissions process. Students may also apply after their first semester of study.

I worked as an adviser to international students for many years before applying to law school. By my third year I had already represented a client in a housing dispute, externed for a Federal Magistrate Judge and the San Francisco Immigration Court, and served as a law clerk at an immigration non-profit. HLP's unique schedule allowed me to take advantage of these opportunities to launch my career in immigration law.

## /// Environmental Law

GGU Law's nationally recognized Environmental Law Program offers students unparalleled opportunities to immerse themselves in this rapidly evolving practice area. Courses are focused on law and policy issues related to climate change, renewable energy, land use, and water rights. Many faculty members and students are active in environmental justice and protection efforts.

#### **Environmental Law Journal**

The GGU Environmental Law Journal, published twice in the academic year, addresses environmental issues relevant to Pacific Rim countries and provides an overview of GGU Law's Annual Environmental Law Symposium.

#### Environmental Law Society



GGU Law's active Environmental Law Society sponsors lectures and panels, sales of eco-friendly products, beach cleanups, and other student-led initiatives throughout the year.

#### Center for Urban Environmental Law (CUEL)

CUEL focuses on policy and regulatory strategies to improve urban environmental conditions. The center also develops law school curricula to ensure the next generation of lawyers is well versed in the implications of environmental law on air and water quality and the impact of climate change in urban settings.

#### Environmental Law and Justice Clinic (ELJC)

Celebrating its 20th anniversary in 2014, the mission of ELJC is to improve the environmental conditions for communities of color and low-income residents of the San Francisco Bay Area. Faculty and staff attorneys collaborate with student clinicians who are trained to interview and counsel clients, develop effective legal strategies, and negotiate with opposing parties.

#### Environmental Law Scholars Program (ELSP)

Qualified entering students are chosen as Environmental Law Scholars, a distinction which includes a \$5,000 annual scholarship, faculty mentoring, and specialized career counseling.

# /// Public Interest

GGU Law is consistently recognized as one of the best public interest law schools in the United States. Our extensive public interest program is supported by faculty whose work reflects the progressive values of the larger San Francisco community.

#### **Clinical Training**



Through GGU Law's award-winning Environmental Law and Justice Clinic, Women's Employment Rights Clinic, Pro Bono Tax Clinic, and numerous off-site externships, students gain direct experience assisting clients with their legal claims. Students advocate for individuals who are struggling to access veterans and other public benefits. Student clinicians also partner with community groups to combat environmental pollution.

#### Scholarships and Salary Assistance

The Public Interest Scholars Program grants \$5,000 annual scholarships to select entering students with extensive public service experience. In addition, GGU Law pays the employer's portion of a work-study award for students working for public interest organizations and government agencies during the summer.

#### Loan Repayment Assistance Program (LRAP)

LRAP offers assistance to graduates employed in low-paying public interest jobs, helping them meet their financial obligations as they pursue careers serving the public good.

#### Public Interest Law Foundation (PILF)

PILF is an active student-led group that hosts a raucous and popular annual fundraising auction to benefit those working in public interest internships during the summer. Over the years, the auction has raised hundreds of thousands of dollars, enabling students to accept unpaid legal positions at advocacy organizations and legal aid offices.

#### **Commitment to Public Service**

The Law Student Pro Bono Project connects students with short-term and long-term volunteer projects around the Bay Area. As volunteers, students staff client intake clinics, engage in legislative advocacy and policy work, and represent low-income families in a variety of substantive legal areas. GGU Law students also participate in our Pro Bono Tax Clinic and offer their time and expertise to an array of community organizations including the La Raza Centro Legal Workers' Rights Clinic, the Student Hurricane Network, the Princess Project, and the San Francisco Food Bank.

My two-year fellowship project is aimed at improving access to healthcare under the Affordable Care Act for Burmese and Bhutanese refugees in the Bay Area. My work experience during law school has prepared me to be successful.

## /// Taxation

GGU Law's tax law curriculum is known for its breadth and depth, and is frequently recognized among the top programs in the western United States. Students benefit from close ties to GGU's highly regarded Braden School of Taxation. Upper-year students can obtain an accelerated LLM in taxation in addition to a JD, taking classes along with seasoned tax practitioners seeking to enhance their professional credentials.

#### Certificate of Specialization in Taxation Law

Studying under experienced faculty, students gain a solid foundation in the basics of federal, state, and local taxation as well as real estate, partnership, corporate, and international tax law. Students may choose to branch out into areas of particular interest, including business taxation, estate planning, and employee benefits.

Students must complete a set number of core courses and electives. Tax-related programs and job fairs are hosted throughout the year by the Young Tax Lawyers Association. Many students join the CAPITAL Group (Corporate Asset-Management Property Investment and Tax Association), an active student organization known for bringing high-profile guest speakers to campus.

#### Pro Bono Tax Clinic

Through the Pro Bono Tax Clinic, law students assist Californians of limited means with appeals filed with the California Board of Equalization. Students analyze issues presented on appeal, conduct research, and prepare legal briefs. The clinic's emphasis on intensive client counseling means that students provide invaluable service to low-income individuals. All students work under the direct supervision of an attorney from the Board of Equalization.

#### **Faculty Coaching**

All first-year students are paired with Faculty Coaches who serve as trusted advisors outside the classroom. Through frequent small group meetings and other activities, Faculty Coaches offer guidance to students as they navigate the first year of law school, develop their professional identity and interests, and build relationships in the legal community.



#### Peer Mentors

Upper-year Peer Mentors are assigned to all new students during orientation to help them acclimate to law school. Serving as ambassadors for the law school and friendly faces on campus, Peer Mentors alleviate common concerns and fears, help students balance the many competing demands of the first year, and offer advice on everything from where to eat lunch to how to form a study group.

#### Academic Development

Our Academic Development Program offers supplemental services, including advising, individual counseling, and specialized workshops to help students enhance their academic performance. Workshops, held throughout the first semester, are aimed at teaching students to succeed in their classes and adapt to the rhythms and demands of the 1L curriculum.

#### **Bar Exam Services**

GGU Law takes success on the bar exam very seriously, preparing students to master the substantive material and become confident test takers well in advance of their final semester. Students can access an array of services prior to taking the bar exam, including targeted workshops, review sessions, and special classes.

## /// Admissions and Financial Aid

#### GGU Law strives to admit a diverse group of students who are seeking a rigorous legal education focused on practical, hands-on training. The Admissions Committee uses objective indicators such as LSAT scores and undergraduate transcripts to determine an applicant's readiness to meet the challenges of legal study. Personal statements, resumes and letters of recommendation further develop the committee's understanding of each applicant's potential for success.

#### Financial Aid

GGU Law awards Dean's and Faculty merit scholarships in varying amounts to qualified entering students. All applicants are automatically considered for these awards. Graduates of California's UC and CSU systems are also considered for California Scholarships, which honor GGU Law's longstanding relationship with California's public universities. In addition, special scholarships are granted to students whose applications show a strong commitment to public service or environmental law.

A variety of federal and private loan programs may be available to entering students. Our experienced Financial Aid staff works with new students to demystify the financial aid process and help them make wise borrowing choices. Applicants must complete the Free Application for Federal Student Aid (FAFSA) after January 1 to be evaluated for loan eligibility.

GGU Law proudly participates in the Yellow Ribbon Program, a provision of the Post-9/11 GI Bill. Eligible students may have the entire cost of tuition met by a combination of scholarships and Yellow Ribbon Program funding.

#### Transfer and Visiting Students

Students seeking to enroll as visiting or transfer students must be currently enrolled at an ABA-accredited law school, in good academic standing, and have completed the first year of study. The application must include a current law school transcript, a letter of reference from a law professor, and a letter from the Dean or Registrar at the applicant's current institution. #### **International Students**

Students who have completed their undergraduate studies outside the United States or Canada must have their transcripts evaluated through the LSAC Credential Assembly Service. A computerbased TOEFL score will be required for any student whose course of study was not completed in English. ## A Rich Tradition of Purpose and Practice

1901 The YMCA establishes California's first evening law school, which will eventually become GGU Law.

1906 The great San Francisco earthquake and fire level the YMCA building. Undaunted, students continue their studies in tents.

1913 Justice Jesse Carter graduates, later joining the Board of Governors of the State Bar of California. He is appointed to the state Supreme Court in 1939.

1928 Margaret Lyons Steffan is one of the first two women to receive a law degree from the newly named Golden Gate College.

1956 The law school is the first exclusively part-time program in the west to receive provisional accreditation by the ABA.

1964 The full-time day program is instituted at the law school.

1973 GGU Law appoints the second woman in the U.S. to be named dean of an ABA-accredited law school.

1979 The addition of GGU Law's robust LLM in Taxation program coincides with the completion of the six-story university building on Mission Street.

1993 The Women's Employment Rights Clinic is established on campus, aiding domestic and immigrant workers facing unfair labor practices.

1994 The Environmental Law and Justice Clinic is inaugurated, improving the quality of life for underserved Bay Area communities.

1998 The Honors Lawyering Program breaks new ground in practical, client-focused training for law students.

2004 GGU Law appoints Frederic White, the first African American dean of an ABA-accredited law school in California.

2010 The Litigation Center and Intellectual Property Law Center are established, enhancing student expertise in courtroom advocacy and scholarship in IP law.

2011 Alumna Morgan Christen, former Alaska Supreme Court Justice, is appointed to the U.S. Court of Appeals for the Ninth Circuit in San Francisco.

2012 Rachel Van Cleave is appointed dean, a former Fulbright Scholar and expert on comparative criminal justice, she is the third woman to assume leadership of GGU Law.
