"Faculty Must Get... Together"

The FSC meeting scheduled for Thursday, September 6 was cancelled by the Faculty after a private meeting, to the surprise of the students who did show up.

Nevertheless, a few faculty members were present to share their views. Mort Cohen, in-term FSC Chair, explained the cancellation:

"I decided, as chair, not to have the FSC meeting yet, until it appears the differences (among the faculty) are resolved."

He also stated that the Faculty is discussing the issue of re-instating students. However, no faculty meeting is scheduled at this time.

Bill Hing felt it was just as illegitimate to cancel the meeting as it was to disenfranchise students, but concluded that it was necessary.

"There are other interests involved," Hing stated, " and one of those interests is getting along with each other." Hing emphasized that the major portion of the problem lies with the faculty and, "we need to get out (act) together before we can deal with students."

"It's too bad the faculty has to get itself together at the expense of the students," Hing added.

Roger Bernhardt claimed that students representatives do not adequately represent the student body as a whole. Other faculty present were Rozella Canty-Letsome, Dru Ramey and Barbara Rhine.

Students, however, were still upset after the explanation by Mort and other faculty members. Judy Bloomberg, third year day student, commented on the fact that because students are labeled as students, they are denied the credibility or wisdom

that teachers have because they are teachers.

"I have as much experience in the world, as much knowledge in terms of what curriculum should be, grading and hiring as the faculty because of my experience...and what I have done as an individual," Judy added.

Once the faculty had expressed their views they were asked to leave, and the students continued without them.

After some discussion, a proposal was ratified by the group declaring that the faculty action of disenfranchising students last summer was invalid.

It was then decided that the FSC representatives selected last spring would meet and make alternative recommendations for the FSC.

Monday night, the SBA met and approved the decisions made at the student meeting. With both a mandate from the SBA and the student body present at Thursday's meeting, the FSC student representatives met Tuesday night and formulated the following proposals:

- 1. The faculty shall reconvene and consider the issue of student part-cipation on the FSC
- 2. The hiring, evaluations, curriculum, admissions, academic standards, and budget committees shall commence their duties as soon as possible.
- 3. The FSC shall function with seven full franchised student representatives, one of whom will be a full voting member of the FSC.

Remeber, this is your paper too. Instead of constantly complaining about the articles or quality of the Caveat, offer to help. It is always easier to complain.



Learn Spanish

This academic year, the law school will offer a course in Spanish for Lawyers in which students working with legal documents in Spanish and English and life situations develop those verbal skills, written and oral, involved in working with a Spanish speaking person. The course will involve a moderate amount of written work and class participation.

Classes will be held on
Tuesdays and Thursdays at 8 am in
room 300. No tuition will be
charged for the class. Credit will
not be given, but a letter of
recommendation will be awarded
to those who satisfactorily complete
the course. The letter will come
from the Dean's office, and it may
be used for future employment,
etc.

This is the second year of the successful program and several of last year's participants obtained employment due to the considerable need for legal personnel able to communicate in Spanish.

"Developing Study Techniques and Coping With Stress" -- A Session for First Year Women Wednesday, September 10th Noon - Room 320 5:30 - Library Conference Room

The vast majority find ourselves juggling school, work, and family and social life -- our broader ambitions with the immediate demands of each day.

Second, third, and fourth-year women will facilitate the sessions and discuss the methods they have fashioned to effectively handle the rigors of law school.
