YEAR END 2017-18 CALIFORNIA STATE LEGISLATIVE SESSION**

AB 12 (Cooley) State government: administrative regulations: review

Requires each state agency to conduct a one-time review of all of its regulations and make specified changes on or before January 1, 2020.

Last Action: Held in Assembly Appropriations Committee

AB 32 (Rodriguez) California State Auditor

Sets a recruitment process for California State Auditor candidates.

Last Action: Chapter 606, Statutes of 2017

AB 77 (Fong) Regulations: effective dates and legislative review

Authorizes the Legislature to override the effective date of a regulation by enacting a statute to override the regulation and requires the Office of Administrative Law to forward a copy of each major regulation submitted to the Secretary of State to the Legislature for review.

Last Action: Held in Assembly Appropriations Committee

AB 92 (Bonta) Public contracts: payment

Extends from January 1, 2018, to January 1, 2023, the sunset date on existing statutes governing the amount of money a public agency can retain from a contractor prior to completion of a public works project.

Last Action: Chapter 37, Statutes of 2017

AB 262 (Bonta & Eggman) Public contracts: lowest responsive bidder: eligible materials

Requires the Department of General Services to establish standards used in the bid process related to greenhouse gas emissions when certain eligible materials are used in state public works projects.

Last Action: Chapter 816, Statutes of 2017

AB 434 (Baker) State Web accessibility: standard and reports

Requires the director and chief information officer of each state agency to post on the home page of the state agency's web site a signed certification that the site is in compliance with specified accessibility standards.

Last Action: Chapter 780, Statutes of 2017

AB 510 (Quirk-Silva) State property acquisition: West Coyote Hills project site

Appropriates an unspecified amount for the 2018-19 fiscal year from the General Fund to the Wildlife Conservation Board to be used for the purchase of the remainder of the West Coyote Hills project site in the City of Fullerton.

Last Action: Held in Senate Appropriations Committee

AB 517 (Harper) State government: travel: political beliefs

Prohibits a state entity from banning an employee or officer from traveling to a state, or denying a request for state-funded travel, on the basis of political beliefs.

Last Action: Held in Assembly Judiciary Committee

AB 547 (Chávez) California Prompt Payment Act: disabled veteran business enterprises

Requires state agencies to pay properly submitted, undisputed invoices from a disabled veteran business enterprise that is also a small business (DVBE/SB) within 30 days of receiving the invoice and makes invoices from dually-certified DVBE/SBs that are not paid within 30 days subject to penalty rates similar to those already paid to SBs.

Last Action: Vetoed 10/10/17

AB 632 (Acosta) Small Business Procurement and Contract Act: disabled veteran business enterprise

Increases the maximum amount for which a state agency can directly contract with a DVBE from \$250,000 to \$500,000.

Last Action: Held in Assembly Appropriations Committee

AB 639 (Obernalte) Department of General Services: contracts: electronic submission

Requires the Department of General Services to develop procedures authorizing the submittal of electronic signatures and documents by all parties on contracts covered by the State Contracting Manual.

Last Action: Vetoed 7/21/17

AB 677 (Chiu) Data collection: Lesbian, Gay, Bisexual, and Transgender Disparities Reduction Act

Expands the list of state entities currently required to collect voluntary self-identification information on sexual orientation and gender identity to include various education and employment-related state agencies.

Last Action: Chapter 744, Statutes of 2017

AB 739 (Chau) State vehicle fleet: purchases

Requires at least 15% of specified heavy-duty vehicles newly purchased by state agencies to be zero-emission (ZEV) beginning in 2025, and at least 30% of those vehicles to be ZEV beginning in 2030.

Last Action: Chapter 639, Statutes of 2017

AB 816 (Kiley) California Environmental Protection Agency: Natural Resources Agency: Web casts of public meetings and workshops

Requires the California Environmental Protection Agency and the Natural Resources Agency to web cast on-site public meetings.

Last Action: Held in Senate Appropriations Committee

AB 822 (Caballero) Institutional purchasers: sale of California produce

Provides bid preferences for the state's purchases of California-grown or California-packed or processed agricultural products.

Last Action: Chapter 785, Statutes of 2017

AB 848 (McCarty) Public contracts: University of California: California State University: domestic workers

Prohibits the University of California and the California State University from contracting for services performed by workers outside of the United States that would displace a UC or CSU employee.

Last Action: Chapter 844, Statutes of 2017

AB 912 (Obernolte) Small business: California Small Business Regulatory Fairness Act

Requires a state agency to assist small businesses in complying with statutes and regulations and to establish policies to reduce, in certain circumstances, civil penalties for noncompliance.

Last Action: Held in Assembly Appropriations Committee

AB 961 (Quirk-Silva) Disabled Veteran Business Enterprise Program

Makes various changes to the monitoring and promotional requirements of the statewide DVBE contracting program.

Last Action: Vetoed 10/13/17

AB 1052 (Travis Allen) the Financial Information System for California

Specifies requirements for FISCAL's public transparency web site.

Last Action: Held in Assembly Appropriations Committee

AB 1057 (Weber) Armories: sales: San Diego Armory

Provides the option for the nonprofit San Diego Center for Children to purchase a section of the San Diego Armory at fair market value.

Last Action: Chapter 147, Statutes of 2017

AB 1080 (Gonzalez Fletcher) Public contracts: bid preferences: employee health care expenditures

Requires a state agency awarding specified contracts to provide a 5% bid preference to a bidder or subcontractor that provides credible health care coverage, as defined, to employees during the 12-month period immediately preceding submission of the bid.

Last Action: Vetoed 9/30/18

AB 1223 (Caballero) Construction contract payments: Internet Web site posting

Requires state agencies that maintain an Internet Web site to post specified information about construction contract payments valued at \$25,000 or more on their Internet Web sites within 10 days of making the payment.

Last Action: Chapter 585, Statutes of 2017

AB 1233 (Cunningham) Transportation Inspector General

Creates the independent Office of the Transportation Inspector General in state government.

Last Action: Held in Assembly Transportation Committee

AB 1246 (Obernolte) State publications: distribution

Allows a member of the public to copy, share, distribute, or republish a state-authored publication.

Last Action: Held in Assembly Appropriations Committee

AB 1385 (Quirk) State contracts: California Council on Science and Technology

Allows specified state entities to enter into a limited number of non-competitive state contracts with the California Council on Science and Technology.

Last Action: Held in Accountability and Administrative Review Committee

AB 1445 (Reyes) Designated qualified opportunity zones: sale or lease of property

Last Action: Re-referred out of Assembly Accountability and Administrative Review Committee

AB 1457 (T. Allen) State Contract Act: suspension of contractors: contempt of Congress

Allows a state agency to prohibit contracting for as long as three years with a person who fails to appear to provide testimony or produce papers when summoned by the United States Congress.

Last Action: Held in Accountability and Administrative Review Committee

AB 1635 (Quirk-Silva) Public contracts: small business participation

Requires state agencies to establish and achieve a goal of 25% small business participation in their procurement activities.

Last Action: Held in Assembly Appropriations Committee

AB 1658 (Frazier) State agencies: accountability

Requires each Secretary of the eight agencies in the executive branch of state government to annually review all programs under his or her jurisdiction by January 1, 2019, and establish specified program metrics and ongoing evaluation requirements.

Last Action: Held in Assembly Appropriations Committee

AB 1709 (Committee on Veterans Affairs) Armories: sales: local agency

Requires that an armory be offered for sale to a local agency, as defined, prior to being offered for sale to private entities or individuals.

Last Action: Chapter 304, Statutes of 2017

AB 1967 (Patterson) Zero net energy project budget requests

Requires a state entity to include a cost-benefit analysis when submitting a request to build or retrofit a state-owned building as zero net energy.

Last Action: Held in Accountability and Administrative Review Committee

AB 1977 (Committee on Accountability and Administrative Review) State real property: surplus

Authorizes the Director of the Department of General Services to dispose of various specified state-owned surplus properties.

Last Action: Chapter 430, Statutes of 2018

AB 2087 (Waldron) State government operations: technology modernization

Requires each state agency, and the Legislature, to establish technology modernization goals that will improve the efficiency of the agency by January 1, 2020.

Last Action: Held in Senate Appropriations Committee

AB 2106 (Eduardo Garcia) Institutional purchasers: sale of California produce

Increases the existing bid preference from 5% to 10% for state purchases, as specified, for California-grown, or California-packed or processed agricultural products over those produced out of state.

Last Action: Held in Senate Appropriations Committee

AB 2157 (Obernolte) Public contracts: noncompetitive bid contracts: report

Requires the Department of General Services to submit an annual report about noncompetitive bid contract requests valued at more than \$1 million to the Legislature and make it publicly available.

Last Action: Held in Assembly Appropriations Committee

AB 2192 (Mark Stone) State-funded research: grant requirements

Expands an open access requirement for state-funded research that currently applies only to the California Department of Public Health to include other specified state agencies.

Last Action: Chapter 296, Statutes of 2018

AB 2198 (Obernolte) State government: FISCAL: transparency

Expands the type of expenditure data required to be available on the Financial Information System for California's public transparency website to include data from special funds.

Last Action: Chapter 186, Statutes of 2018

AB 2199 (Irwin) State budget

Requires the Director of the Department of Finance (DOF) to notify the author of enacted legislation when DOF proposes during the budget process to delay or modify the effective date of the enacted legislation.

Last Action: Held in Senate Budget and Fiscal Review Committee

AB 2251 (Melendez) State agencies: audits

Directs the California State Auditor to evaluate state programs for duplication with federal programs and requires specified performance reviews of state employees.

Last Action: Held in Accountability and Administrative Review Committee

AB 2252 (Limón) State grants: state grant administrator

Requires the California State Library, by July 1, 2020, to create an online funding opportunity portal that provides grant seekers a central location for state grant information.

Last Action: Chapter 318, Statutes of 2018

AB 2361 (Weber) University of California: outsource contracts

Requests that the University of California post on a publicly available website specified types of contracts, contract information, and information about contractors' employees and their wages and benefits.

Last Action: Vetoed 9/30/18

AB 2371 (Carrillo) Water use efficiency: landscape irrigation

Last Action: Re-referred out of Assembly Accountability and Administrative Review Committee

AB 2396 (Bigelow) Public contracting: conflicts of interest: exemption

Exempts an employee or state officer of a district agricultural association (DAA) from a current conflict of interest prohibition for purposes of contracting with another DAA if approved by the DAA Board of Directors.

Last Action: Chapter 215, Statutes of 2018

AB 2475 (Ting) State-owned property: sustainable landscaping

Requires the Department of General Services, at least every five years, to review regulations and practices for sustainability, energy efficiency, and water efficiency for landscapes on state-owned property to ensure they reflect the most current standards.

Last Action: Held in Senate Governmental Organization Committee

AB 2506 (Burke) State vehicle fleet: near-zero-emission vehicles

Requires at least 15% of specified new heavy-duty vehicles purchased by state agencies to be fueled by renewable natural gas beginning on January 1, 2022.

Last Action: Held in Assembly Appropriations Committee

AB 2543 (Eggman) State agencies: infrastructure project budget and schedule: Internet Web site information

Directs state agencies and departments to post specified information about changes in the cost or schedule of large infrastructure projects on their websites.

Last Action: Chapter 918, Statutes of 2018

AB 2671 (Fong) Regulations: legislative review: regulatory reform

Requires the Office of Administrative Law to forward a copy of each major regulation to the Legislature for review; allows the Legislature to enact a statute to override the effective date of a regulation; and requires every state agency to conduct a one-time review of its regulations and take specified action on those identified as duplicative, overlapping, inconsistent, or out of date.

Last Action: Held in Assembly Appropriations Committee

AB 2729 (Muratsuchi & Gipson) California State Auditor

Sets approval requirements for audits and related work under the California State Auditor's high-risk local government agency audit program and allows the Auditor to limit or discontinue audit work.

Last Action: Held in Senate Appropriations Committee

AB 2734 (Frazier) California Transportation Commission

Removes the California Transportation Commission from the California State Transportation Agency and establishes it as an independent entity in state government.

Last Action: Vetoed 9/14/18

AB 2749 (Bonta) State agencies: state entities: Internet Web site accessibility: standards: mobile-friendly: requirements

Makes a public website maintained by a state agency or entity operational only if it is mobile friendly and accessible by persons with disabilities and requires the agency or entity to certify that its website is accessible on a mobile device.

Last Action: Vetoed 9/22/18

AB 2764 (Chau) State acquisition of information technology goods and services: exemptions

Makes Department of Technology contracts subject to the same contractor prohibitions, certifications, and restrictions in existing law that currently apply to Department of General Services contracts.

Last Action: Chapter 220, Statutes of 2018

AB 2777 (Daly) State employees: travel reimbursements

Extends, until January 1, 2022, the sunset date in existing law that prevents state agencies from prohibiting the use of transportation network companies or short-term rentals for employees traveling on official state business.

Last Action: Chapter 719, Statutes of 2018

AB 2790 (Irwin) Veterans: Internal Audits for Veterans Affairs

Creates the office of Internal Audits for Veterans Affairs within the California Department of Veterans Affairs.

Last Action: Vetoed 9/11/18

AB 2822 (Oberholte) California State Auditor: high-risk local government agency audit program

Allows the California State Auditor to review publicly available information when identifying local government agencies that are high risk under the Auditor's high-risk local government agency audit program.

Last Action: Chapter 498, Statutes of 2018

AB 2971 (Calderon & Cooley) State agencies: administrative regulations: review

Requires each state agency to conduct a one-time review of its regulations.

Last Action: Held in Assembly Appropriations Committee

AB 2987 (Patterson) Public contracts: bidding: Business Enterprises Program for the Blind

Changes the Department of Rehabilitation's contracting requirements for its Business Enterprise Program for the Blind.

Last Action: Held in Accountability and Administrative Review Committee

AB 3090 (Gloria) State property: Department of the California Highway Patrol

Authorizes the Director of the Department of General Services to dispose of a former California Highway Patrol facility in San Diego County.

Last Action: Held in Accountability and Administrative Review Committee

AB 3179 (Salas) State agencies: bilingual services

Reduces the threshold by which state agencies are required to provide language access services to a substantial number of non-English speakers from 5% to 3%.

Last Action: Vetoed 9/22/18

AB 3185 (Patterson) The Financial Information System for California (FISCal): California State Auditor

Changes the date when the California State Auditor must report annually on the Financial Information System for California.

Last Action: Held in Accountability and Administrative Review Committee

AB 3251 (Committee on Veterans Affairs) Sale of armories

Authorizes the Director of the Department of General Services, with the approval of the Adjutant General of the California Military Department to sell specified armory properties.

Last Action: Chapter 726, Statutes of 2018

SB 30 (Lara) Insurance: climate change

Last Action: Re-referred out of Assembly Accountability and Administrative Review Committee

SB 173 (Dodd) Real estate: Bureau of Real Estate

Changes the location within state government of the California Bureau of Real Estate and renames it the Department of Real Estate.

Last Action: Chapter 828, Statutes of 2017

SB 401 (Pan) Child care facilities: state employees

Removes the existing limit on the allowable area of indoor space that can be used for child care within state-owned office buildings.

Last Action: Chapter 235, Statutes of 2017

SB 498 (Skinner) Vehicle fleets: zero-emission vehicles

Directs the Department of General Services to ensure that at least 50% of the state's light-duty vehicle fleet purchases each fiscal year (FY) are zero-emission vehicles (ZEVs), beginning no later than the 2024-25 FY, and requires the Air Resources Board to review its ZEV programs and make specified recommendations to the Legislature by July 1, 2019.

Last Action: Chapter 628, Statutes of 2017

SB 574 (Lara) University of California: contracts: bidding

Modifies the requirements to qualify as a lowest responsible bidder or best value awardee for certain types of contracts at the University of California by requiring a bidder to certify in writing that its employees are compensated at a level that does not undercut, by more than five percent, the average per-employee value of total compensation for UC employees who perform comparable work at a campus, medical center, or laboratory.

Last Action: Vetoed 10/15/17

SB 702 (Stern) State vehicles: bicycles

Requires the Department of General Services to expand the State Employee BikeShare Program throughout the state, as specified.

Last Action: Vetoed 10/9/17

SB 814 (Committee on Governmental Organization) State real property: surplus

Authorizes the Director of the Department of General Services to dispose of a portion of the former Preston Youth Correctional Facility in Amador County.

Last Action: Chapter 815, Statutes of 2017

SJR 6 (Pan & de León) AmeriCorps

Calls on the United States Congress to protect and sustain full funding for the Corporation for National and Community Service, the federal entity that administers the national service program known as AmeriCorps.

Last Action: Chapter 124, Statutes of 2017

SB 984 (Skinner) State boards and commissions: representation: appointments

Requires, by January, 1 2024, each appointed state board and commission has minimum percentages or numbers of women members.

Last Action: Held in Assembly Appropriations Committee

SB 1162 (Pan) Capitol area planning: height limits

Removes a parcel located at 1619 N Street in the City of Sacramento from the area subject to height restrictions established in the Capitol View Protection Act of 1992 and, instead, designates Matsui Alley as the southern boundary of the area.

Last Action: Chapter 415, Statutes of 2018

SB 1179 (Newman) Public contracts: Disabled Veteran Business Enterprise Program

Requires an awarding department to give a prime contractor that fails to comply with specified certification requirements under current law, reasonable opportunity to comply with those requirements.

Last Action: Held in Assembly Jobs, Economic Development, and the Economy Committee

SB 1180 (Newman) California Disabled Veteran Business Enterprise Program

Requires an awarding department to maintain all records of the information currently provided by a prime contractor that entered into a subcontract with a disabled veteran business enterprise and to retain those records for a minimum of six years, as specified.

Last Action: Held in Assembly Jobs, Economic Development, and the Economy Committee

SB 1293 (Lara) California State Auditor: high-risk local government agency audit program

Allows, after first notifying the Joint Legislative Audit Committee, the California State Auditor to conduct initial assessments when determining if an entity is high risk under the Auditor's high risk local government agency audit program.

Last Action: Chapter 515, Statutes of 2018

SB 1316 (Glazer) Off-highway vehicular recreation: Carnegie State Vehicular Recreation Area: Alameda-Tesla Expansion Area

Permits the Department of Parks and Recreation to dispose of a portion of the Carnegie State Vehicular Recreation Area, known as the Alameda-Tesla Expansion Area, if specified conditions are met.

Last Action: Held in Assembly Appropriations Committee

SB 1505 (Committee on Governmental Organization) State contracts: procurement processes

Changes posting and reporting processes in state procurement.

Last Action: Chapter 335, Statutes of 2018

SB 1509 (Committee on Governance and Finance) State finance

Exempts the State Treasurer from the rulemaking requirements of the Administrative Procedure Act when entering into state bond-related service agreements, including the establishment of pools of eligible contractors.

Last Action: Chapter 931, Statutes of 2018
