NEW CHANGES

LAW 855 Professional Presentation & Persuasion (formerly Courtroom as Theater) §LS2 has been **added** to the fall course schedule on **Fridays at 11:30-1:10 PM**. The time of the §LS1 section has been moved back 15 minutes to **1:30-3:10 PM**.

Changes listed below were made after the fall courses were posted on the law school website, but before the hardcopy schedule was printed. They have been incorporated in the published schedule.

LAW 727E Advanced Legal Research §LS3 has been **added** to the fall 2012 course schedule. Section **§LS2** will be for students on **Law Review**, and the new section **§LS3** will be for students on the **Environmental Law Journal (ELJ)**. Sections **§LS2** and **§LS3** are both 1-unit and both require the instructor's approval to register.
