ABA LAW STUDENTS ELECT FIRST WOMAN PRESIDENT

Lynne Z. Gold is the newly-elected president of the American Bar Association's 20,000-member Law Student Division, the nation's largest organization of law students. Gold, 37, a third-year student at Villanova Law School, Villanova, Pa., is the first woman to hold the office of Law Student Division president. She entered law school after raising four children, being in theatre for 10 years and, for a year and a half, serving as moderator of the television show, "Off the Pedestal," about women who have chosen alternate life styles other than the traditional housewife role.

FIRST ANNUAL LAWYER'S CLUB SCHOLARSHIP TO SAMUEL BARNUM OF GGU LAW SCHOOL

Samuel Barnum, second-year student at Golden Gate University School of Law, has received the Lawyers' Club of San Francisco's first annual Scholarship Fund Foundation award, it was announced by Lawyers' Club president James D. Hadfield.

In a recent ceremony at GGU School of Law, Sam was presented a check in the amount of \$500 by Gerald Marcus, President of the Scholarship Fund Foundation's board of trustees, Ruth Church Gupta, president-elect of the Lawyers' Club of San Francisco, and Foundation trustee John Finger.

The scholarship, which memorializes the late Allen E. Spivock, founder and first president of The Lawyers' Club, is tenable in rotating order at the seven Bay Area law schools approved by the American Bar Association. The order, determined by lot, resulted in the first annual award being made to a Golden Gate law student. In future years, scholarship recipients will be selected from Boalt Hall School of Law, Hastings College of the Law, San Francisco Law School, Stanford School of Law, the University of Santa Clara School of Law, and the University of San Francisco School of Law.

Sam and Judith G. McKelvey, dean of GGU School of Law, will be honored guests of the Lawyers' Club of San Francisco at its annual installation luncheon on November 13 at the Sheraton Palace Hotel in San Francisco.

Bay Area Law School Libraries' Policies

Nancy Carol Carter, Director of Law Library Services at GGU School of Law has been trying to make life easier for those of us who find it more convenient to use other law schools' libraries during the weekend and evenings. She has been in contact with the librarians of these schools and is willing to act as a liaison between a student who feels s/he has been discriminated against in another law school library and the library administration of that school.

Below is an explanation of the exclusionary policies established in two of the local law schools, Boalt and Stanford.

The official policy at Boalt Hall regarding law library use by outside students is to allow unrestricted in-building access and use of all material, except those on reserve. Reserve materials are checked out only to students enrolled at Boalt Hall because the library administration feels obligated to first serve its own student population. This prohibition is enforced against all outside users and there is no official policy of discrimination against GGU students. A law librarian at Boalt Hall has agreed to check into any reports of such discrimination or denied access to open stack materials. Report any complaints to Nancy Carol Carter, Director of Law Library Services at GGU.

Stanford University Law Library Policies

All libraries at the Stanford campus are required to restrict library use to enrolled student because of a recent directive from the President's office. User permits are available at a price of \$50.00 per year for non-enrolled individuals wishing to use Stanford libraries. The law librarian at Stanford has been approached about making exceptions to the policy for GGU students who live in the Palo Alto area. No exceptions are allowed.

FALL SEMESTER STUDENT EVALUATIONS

Fall semester student evaluations will be taken in all courses during the week of October 27, 1975. In most cases, student members of the Evaluation Committee will be coming to your classes, at the commencement of the class period, to distribute the evaluation forms and obtain their completion.

GGU'S DISTINGUISHED SERVICE AWARD

The 1975 distinguished service award of the Associates of GGU was presented Wednesday, October 22, 1975 to Paul S. Jordan for outstanding contributions to the legal profession and to the University.

A practicing attorney in San Francisco for five decades, Jordan has been connected with GGU nearly as long. He joined the faculty as a lecturer in law in 1933, was dean of the law school from 1944 to 1959, and has been a member of the University's board of trustees since 1961, and has served as secretary of the governing body for the past 11 years. During his tenure as dean, the law school was accredited by the State Bar of California and received American Bar Association approval. GGU awarded him the honorary degree of doctor of laws in 1973.

A graduate of University of California's Boalt Hall in 1926, he was admitted to the State Bar in the same year.
