**GGU Law Professors Awarded Fulbright Fellowships**

*Golden Gate University School of Law Professors Helen Hartnell and Eleanor Lumsden  
Awarded Fulbright Fellowships*

San Francisco, CA (July 2 , 2012)- Golden Gate University School of Law is proud to announce that two professors have been granted prestigious fellowships as Fulbright Scholars for the 2012-13 academic year. Professor Helen Hartnell will spend the fall semester at the University of Helsinki. She will research in two areas: incorporating the judiciary into a pan-European legal system, and developing a closer sub-regional integration in Nordic Europe (following a proposal to create a federal union there). In addition, Professor Hartnell will teach an advanced course on European Union Law.

Assistant Professor Eleanor Lumsden will travel to Jamaica to spend an academic year at the University of the West Indies at Mona. She will research the impact of technology on development in Jamaica and how broadened laws about microfinance might facilitate change and lessen poverty. She also will teach an introductory U.S. Business Law course at the University.

The Fulbright Program is the flagship international educational exchange program sponsored by the federal government. The program aims to increase mutual understanding between the people of the U.S. and other countries. Recipients of Fulbright grants are selected on the basis of academic or professional achievement, as well as leadership potential in their fields. GGU Law boasts five other Fulbright faculty scholars: Leslie Burton (Czech Republic); Cliff Rechtschaffen (Slovenia); Susan Rutberg (Czech Republic); Jon Sylvester (Kenya); and incoming Interim Dean Rachel Van Cleave (Italy).
